GRAIN INSPECTION FEES AND CHARGES

EFFECTIVE DATE: APRIL 1, 2007.
FEDERAL GRAIN INSPECTION SERVICE (FGIS)
MUST APPROVE ALL FEES FOR OFFICIAL
SERVICES AND OA'S WILL ASSESS ONLY THOSE
FEES APPEARING ON THEIR CURRENT APPROVED
SCHEDULE. THIS SCHEDULE SUPERSEDES THE
FEE SCHEDULE APPROVED ON JULY 1, 2005.

REGULAR HOURS AND HOURLY RATE: 7:00 A.M. TO 4:00 P.M., MONDAY THROUGH FRIDAY, EXCEPT HOLIDAYS. ALL OTHER HOURS WILL BE CONSIDERED OVERTIME. \$18.00 PER HOUR PER INDIVIDUAL WITH A 1-HOUR MINIMUM, WILL BE ASSESSED IN 1/4-HOUR INCREMENTS FOR ALL SERVICES WHERE AN HOURLY RATE IS INDICATED.

OVERTIME-HOURLY RATE: \$27.00 PER HOUR PER INDIVIDUAL WILL BE ASSESSED IN 1/4-HOUR INCREMENTS. A 4-HOUR MINIMUM WILL BE ASSESSED EXCEPT ONE HOUR BEFORE OR CONTINUATION OF REGULAR HOURS.

HOLIDAYS: NEW YEAR'S DAY, MEMORIAL DAY, INDEPENDENCE DAY, LABOR DAY, THANKSGIVING DAY, AND CHRISTMAS.

MILEAGE RATE \$.36 PER MILE FOR TRAVEL OUTSIDE CITY LIMITS OF LEWISTON AND CLARKSTON. MILEAGE WILL BE PRORATED WHEN POSSIBLE.

AN HOURLY FEE OF \$18.00 PER HOUR WILL BE CHARGED AS TRAVEL TIME WHEN DISTANCE IS OVER 25 MILES. ACTUAL MOTEL EXPENSES UP TO \$55.00 PER PERSON PER DAY PLUS AN ALLOWANCE OF \$25.00 PER PERSON PER DAY FOR MEALS WHEN EMPLOYEES ARE NEEDED TO REMAIN OVERNIGHT TO PROVIDE SERVICE.

FEDERAL GRAIN INSPECTION SERVICE SUPERVISION FEES ARE INCLUDED IN THE UNIT FEE. ADDITIONAL USER FEES WILL BE ASSESSED FOR COMPOSITE/COMBINED LOT INSPECTION.
