Federal Grain Inspection Service must approve fees for official services and official agencies will assess only those fees appearing on their current approved fee schedules.

**Regular Hours,** Cedar Rapids, IA, Clinton, IA, Decatur, IL, Elwood, IL, Corpus Christi, TX, Ft. Worth, TX, Peoria, IL

0700 – 1500 Hours. Monday through Friday, except holidays.

**Regular Hours,** Clayton, IA , Winona, WI

0700 - 1700 Hours. Monday through Friday, except holidays.

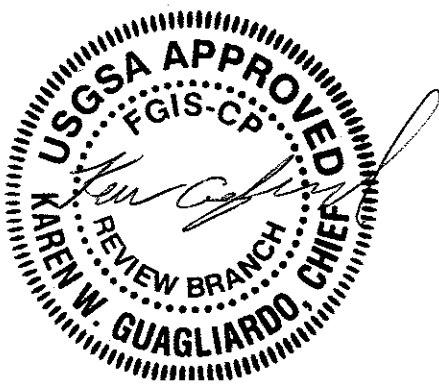
**Overtime Hours:** Saturday and all other weekly hours, other than regular regular hours, shall be considered overtime. For services performed outside of regular hours overtime shall be applicable.

**Call Out Hours:** A minimum of 4 hour per person will be assessed at the applicable hourly rate when requests for service are withdrawn or in the event of requests resulting in personnel returning to duty after dismissal. When the minimum applies no travel time will be assessed.

**Standby Rates:** Will be assessed at the applicable hourly rate for delays not caused by the agency.
