

As a vendor or exhibitor at the Health & Safety EXPO you are expected to:

- **1.** Wear appropriate clothing. (NO OPEN-TOED SHOES during set-up, EXPO, or take down).
- **2.** Ensure your display is set up on Monday May 17 between 7:00 am and 4:00 p.m.
- **3.** Tailor your display to the general public.
- 4. Leave exhibit up for the entire duration of the event (Please do not leave early)
- **5.** Bring your supplies. Common items forgotten include; electrical extension cords, scissors, step stools, small ladders, tape, and display boards. EXPO will provide partitions, chairs, skirted tables, and electricity.
- 6. Make arrangements to have your booth supplies removed from the TRAC facility <u>BEFORE 9:00 A.M. ON MAY 19.</u> Ensure your representative is with your display until all your items are removed from the TRAC facility (This includes the morning of May 20 from 7:00 a.m. until removed).
- 7. Promote products or services utilizing the "Soft-Sell" approach. Product or services may be sold <u>ONLY</u> if participants inquire about purchasing them.
- 8. Provide a price list of your merchandise or services <u>ONLY</u> upon attendees request.
- **9.** Get brochures, giveaways and literature pre-approved by the Topics and Exhibits Team, if it has not been <u>approved</u> you may <u>NOT</u> be allowed to use it. STICKERS, TATTOOS AND BALLOONS ARE NOT ACCEPTABLE GIVEAWAYS.
- **10.** Contact Owen Berglund if you have confirmed a booth, and you cannot attend.
- **11.** Contact the Information booth at EXPO if you plan to leave your display unattended for more than 30 minutes.

As a vendor or exhibitor at the Health & Safety EXPO you are NOT expected to:

- 1. Do anything unsafe. (<u>NO STANDING ON CHAIRS OR TABLES</u>.)
- 2. Aggressively sell your products or services. (NO PRICING OF MERCHANDISE OR SERVICES IS ALLOWED. HANDOUTS MAY NOT HAVE PRICING ON THEM, UNLESS PREAPPROVED).
- 3. Solicit for donations, pay for raffles, or fund-raising drives.
- 4. Stick anything to the curtains, tables or the floors of your booth.
- 5. Give-away items that could create choking hazards.
- 6. Give-away samples of food or beverages (including water) without express written consent from the Topic and Exhibits Team.

It is our intent to ensure attendees, vendors, and guests have a <u>SAFE</u> and <u>MEMORABLE</u> experience at EXPO. Please help us by following these few simple rules.
