Subj: PRECEPT CONVENING A SELECTION BOARD TO RECOMMEND OFFICERS OF  
THE COAST GUARD ON THE ACTIVE DUTY PROMOTION LIST FOR  
PROMOTION TO THE GRADE OF LIEUTENANT

1. Pursuant to the authority provided by references (a) and (b), a Selection Board is appointed consisting of yourself as President and the following members:

CDR Katherine F. Tiongson, USCG - Member  
CDR Kenneth D. Ivery, USCG - Member  
LCDR Brian L. Durr, USCG - Member  
LCDR Karen R. Anderson, USCGR - Member  
LT Michelle C. Bas, USCG - Member

LT Neal D. Hinkel, USCG - Non-voting Recorder

2. The Board shall convene at 0830, 25 September 2006, in suite 501, Coast Guard Personnel Command, or as soon thereafter as practicable, for the purpose of considering all officers in the grade of lieutenant (junior grade) who are eligible for consideration for promotion to the grade of lieutenant in the Coast Guard. Members of the Board shall swear or affirm that they will, without prejudice or partiality, and having in view both the special fitness of officers and the efficiency of the Coast Guard, perform the duties imposed upon them.

3. There is hereby established a promotion zone of 492 lieutenants (junior grade) on the Active Duty Promotion List consisting of the most senior officer in the grade of lieutenant (junior grade); namely, LTJG Anya Fay Hunter, USCG, and those 491 officers junior thereto who have not been previously included in a promotion zone, through and including LTJG Michael P. Wysong, USCG. There are 21 officers above the zone and no eligible officers below the zone.

**Subj: PRECEPT CONVENING A SELECTION BOARD TO RECOMMEND OFFICERS OF THE COAST GUARD ON THE ACTIVE DUTY PROMOTION LIST FOR PROMOTION TO THE GRADE OF LIEUTENANT**

The names and records of all officers to be considered for promotion shall be furnished to the Board. The 468 best qualified officers shall be recommended for promotion.

4. The Board may identify several officers of particular merit, from those chosen for promotion, and recommend them for In Zone reordering and placement at the top of the list of selectees, if at least two-thirds of the members of the Board agree. The Board is under no obligation to employ In Zone reordering; however, if employed, the number of officers selected for reordering will be limited to 5 percent of the total number authorized to be recommended for promotion (up to 23 officers). Officers above and in zone are eligible for reordering if selected for promotion. The selected officers will be reordered in the list of selectees as identified by the Board upon approval by the Secretary.

5. Prior to the date the Board submits its report, the Commander, Coast Guard Personnel Command, is authorized to delete the name of any officer whose name is removed from the Active Duty Promotion List for any reason. In the event any officer in the promotion zone established herein is removed prior to the date the Board submits its report, the Commander, Coast Guard Personnel Command will provide additional instructions. Any communications to the Board by any officer under consideration will be transmitted under separate cover.

6. The Board shall refer to the provisions of Sections 5.A and 14.A of reference (c) and the enclosed Commandant's Guidance to PY07 Officer Selection Boards in your development of criteria for determining the officers recommended for selection. Section 14.A.3 of reference (c) provides four factors to consider in developing your criteria: performance, professionalism, leadership, and education.

7. You should emphasize to the members of the Board the importance of their obligation to confine themselves to facts of record and not predicate judgments on rumor or hearsay. At the end of your deliberations, all members must be able to say that the officers recommended for promotion are, in the opinion of at least two-thirds of the members of the Board, the best qualified to carry out the duties and responsibilities of the grade for which they are selected.

8. The Board shall submit a report in writing signed by all members of the Board. Except for the report of this Board, the proceedings of the Board shall not be disclosed to any person not a member of the Board. You will direct the members of the Board that their recommendations shall be kept confidential until the Secretary approves the report on behalf of the President, and the names of officers selected for promotion are released to the Service at large.
