# Sector Command Master Chief (CMC) and Senior Chief (CSC) Silver Badge

#### **Overview**

Command Master Chiefs (CMCs) represent their commander, communicating the commander's goals and direction for the command to the field, while simultaneously representing the field's views and concerns to the commander. CMCs provide a "field reality check" as they provide input to high level policy makers. They also act as the "resource person" assisting CG personnel and subordinate commands as required. Although CMCs are not in the chain of command, they strengthen it by working within the chain of command whenever possible to provide "ground truth" feedback. They enhance communication and foster a better understanding of the needs and viewpoints of all member of the CG family. For a complete job description please read COMDTINST 1306.1B.

- You must be an E-7, E-8 or E-9
- You MUST meet the Special Assignments criteria outlined in the PERSMAN, <u>Arts.</u>
   4.E.2.A and the Command Senior Enlisted Leadership Program, <u>COMDTINST 1306.1B</u>

If applicable "member prescreened and meets minimum requirements for Overseas Assignment."

New assignments will be 4 years. Incumbents will have assignment tour lengths adjusted according to the date they were assigned as a Collateral Duty Command Master/Senior or Chief. Example - If you have been assigned as a Command Master Chief for 1 year you will be given a 3 year tour.

Competitive applicants have the highest moral and ethical standards, demonstrated leadership roles, embody the Coast Guard core values, exhibit exemplary grooming and fitness, as well as maturity, even temperament and outstanding judgment. An applicant must have excellent "people" and public speaking skills.

*High Year Tenure Waivers* – must be addressed on a separate memorandum with command endorsement. Waivers should include current time in service (pay base date), desired tour length (2-4 years) and career/retirement intentions at completion of assignment.
