

## Gypsy Moth Quarantine

Federal regulations prohibit the movement of certain articles from those parts of the county regulated for gypsy moth to any unregulated part of the United States. Contact plant regulatory officials in your State department of agriculture or the U.S. Department of Agriculture's Animal and Plant Health Inspection Service for assistance regarding requirements for moving regulated articles. For detailed information, consult title 7 of the Code of Federal Regulations, part 301.45.

### Articles Requiring Inspection and Certification Prior to Movement

Nursery stock and Christmas trees; Logs, pulpwood, and wood chips; Mobile homes and associated equipment; and Outdoor household articles, such as outdoor furniture, barbecue grills, firewood, doghouses, boats, recreational vehicles, trailers, garbage containers, bicycles, tires, tents, awnings, garden tools, etc.

### Quarantine Areas

The following States are entirely within the quarantine area: Connecticut, Delaware, the District of Columbia, Maryland, Massachusetts, Michigan, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont.

Parts of the following States are within the quarantine area:
