- The sub-team will work more closely with the related IWG sub-team
- The sub-team task will be revised to include the following:
  - Map the legacy and COTS sub-processes for UID marking (team TBD)
  - Develop the legacy and COTS business rules for UID (team TBD)
  - Define metadata business rules for UID (Andresen to begin efforts)
