COYOTE MOUNTAINS WILDERNESS 18,595 Acres Designated October 31, 1994 by the California Desert Protection Act, Public Law 103-433

This is the final legal description as required in Section 103(b) of the above mentioned Act. It describes the boundary for the Coyote Mountains Wilderness Area located in Imperial County, California and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

Beginning at the closing corner of Sections 18 & 19, on the range line between T. 15 S., Rgs. 8 & 9 E., San Bernardino Meridian (SBM), said point being the point of beginning and identical with the intersection of the Anza-Borrego Desert State Park boundary;

thence easterly between Sections 18 & 19, 17 & 20, 16 & 21, 15 & 22, 14 & 23 and 13 & 24, T. 15 S., R. 9 E., along the Anza-Borrego Desert State Park boundary, to point 1, the intersection of the range line between T.15 S., Rgs. 9 & 10 E., SBM:

thence continuing easterly between Sections 18 & 19 and 17 & 20, T.15 S., R. 10 E., SBM and leaving Anza-Borrego Desert State Park boundary, to point 2, the intersection of the southwesterly edge of a right-of-way, said intersection located near the west 1/16 corner of Sections 17 & 20;

thence southeasterly on the southwesterly edge of said right-of-way, to point 3, the intersection of a line parallel with and 30 feet westerly of the centerline of a jeep trail, located in the northeast 1/4 of Section 20;

thence southerly, changing to southwesterly and parallel with and 30 feet westerly, changing to northwesterly of said centerline for approximately 3 miles, to point 4, the intersection of a line parallel with and 30 feet easterly of the centerline of a jeep trail located in the southeast 1/4 of Section 31;

thence northerly, parallel with and 30 feet easterly of said centerline to point 5, the intersection of a line parallel with and 30 feet northerly of the centerline of a jeep trail, located in a wash in the northeast 1/4 of Section 31;

thence westerly, parallel with and 30 feet northerly of said centerline to point 6, the intersection of a line parallel with and 30 feet northeasterly of the centerline of a jeep trail, located in the northeast 1/4 of Section 36;

thence northwesterly, parallel with and 30 feet northeasterly of said centerline to point 7, the intersection of the north-south centerline of the northeast 1/4 of the northeast 1/4 of section 36;

thence northerly on the north-south centerline of the northeast 1/4 of the northeast 1/4 of said section to point 8, the East-East 1/64 corner of Sections 25 and 36;

thence westerly between Sections 25 & 36 to point 9, the intersection of line 1-2 of the Creole Extension Placer, M.S. No. 5874;

thence northwesterly along said line to point 10, identical to corner 2 of the Creole Extension Placer, and corner 1 of the Creole Extension Placer No. 2, both of M.S. No. 5874;



thence continuing northwesterly along line 1-2 of the Creole Extension Placer No. 2 to point 11, identical to corner 2 of the Creole Extension Placer No. 2, and corner 1 of the Creole Extension Placer No. 3, both of M.S. No. 5874;

thence continuing northwesterly on line 1-2 of the Creole Extension Placer No. 3, M.S. No. 5874 to point 12, the intersection of the north-south centerline of the northwest 1/4 of the southwest 1/4 of Section 25;

thence northerly on the north-south centerline of the northwest 1/4 of the southwest 1/4 of said section to point 13, the Center West-West 1/64 corner of said Section 25;

thence westerly on the east-west centerline of Section 25 to point 14, the 1/4 corner of Sections 25 and 26;

thence northerly between Sections 25 and 26 to point 15, the intersection of a line parallel with and 30 feet northerly of the centerline of a jeep trail;

thence in a generally northwesterly direction, changing to southeasterly, parallel with and 30 feet northeasterly, changing to southwesterly of said centerline to point 16, the intersection of a line parallel with and 30 feet northerly of the centerline of a jeep trail, located in the southeast 1/4 of Section 27;

thence westerly parallel with and 30 feet northerly of said centerline to point 17, the junction with a wash, located in the north ½ of the southeast 1/4 of Section 28;

thence southerly along the thread of said wash to point 18, the junction with a wash, located in the south ½ of the southeast 1/4 of Section 28;

thence southeasterly to point 19, the East-East 1/64 corner of sections 28 & 33;

thence easterly between Sections 28 & 33 and 27 & 34 to point 20, the corner of Sections 26, 27, 34 and 35;

thence southerly between Sections 34 & 35 to point 21, the 1/4 corner between Sections 34 & 35;

thence easterly on the east/west centerline of Section 35 to point 22, the center 1/4 corner of Section 35;

thence southerly on the north/south centerline of Section 35 to point 23, the 1/4 corner between Sections 2 & 35 on the township line, Tps. 15 & 16 S., R. 9 E., SBM;

thence westerly along said township line between Sections 2 & 35 to point 24, the corner of Sections 2, 3, 34 and 35;

thence southerly between Sections 2 & 3 to point 25, the 1/4 corner between Sections 2 & 3;

thence easterly along the east/west centerline of Sections 2 & 1 to point 26, the intersection of line 1-4 of the No. 18 Marble Placer, M.S. 6012;

thence southeasterly along said line to point 27, identical to corner 4 of the No. 18 Marble Placer, M.S. 6012;

thence northeasterly, along line 3-4 of the No. 18 Marble Placer to point 28, identical to corner 3 of the No. 18 Marble Placer, and corner 4 of the No.19 Marble Placer, both of M.S. 6012;



thence continuing northeasterly along line 4-3 of the No. 19 Marble Placer to point 29, identical to comer 3 of the No. 19 Marble Placer, M.S. 6012;

thence northeasterly to point 30, the intersection of a line parallel with and 30 feet southerly of the centerline of a jeep trail in Painted Gorge and the range line between sections 1 and 6, T. 16 S., Rgs. 9 & 10 E., SBM;

thence northeasterly, parallel with and 30 feet southeasterly of said centerline to point 31, the intersection of the 600 feet contour elevation line;

thence easterly, changing to southerly, changing to southwesterly, along said 600 feet contour elevation line to point 32, the intersection of the section line between sections 12 and 13, T. 16 S., R. 9 E., SBM;

thence westerly between Sections 12 & 13, 11 & 14 and 10 & 15 to point 33, the East 1/16 corner between Sections 10 & 15;

thence northwesterly to point 34, the South 1/16 corner between Sections 9 & 10;

thence northwesterly to point 35, the 1/4 corner between Sections 5 & 8;

thence westerly between Sections 5 & 8 to point 36, the corner of Sections 5, 6, 7 and 8;

thence northerly between Sections 5 & 6 to point 37, the 1/4 corner between Sections 5 & 6;

thence westerly on the east/west centerline of Section 6 to point 38, the West 1/4 corner of Section 6 only and identical to the intersection of the Anza-Borrego Desert State Park boundary, on the range line, T. 16 S.,R. 8 & 9 E., SBM;

thence northerly along said range line, along the Anza-Borrego Desert State Park boundary to point 39, the township corner of sections 6 and 31, T. 15 and 16 S., R. 9 E.;

Thence northerly along the range line between T. 16 S., R. 8 E., and T. 15 S., R. 9 E., along the Anza-Borrego Desert State Park boundary to point 40, the township corner of sections 1 and 36, T. 15 and 16 S., R. 8 E.;

thence northerly along the range line between T. 16 S., Rgs. 8 and 9 E., along the Anza Borrego Desert State Park boundary to the point of beginning.

END OF DESCRIPTION

The above description containing approximately 18,595 acres utilizes the Carrizo Mountain and Painted Gorge 7.5 minute quadrangle maps prepared by the United States Geologic Service. The boundary calls listed herein are in part a result of scaling distances from said quad maps and are not a result of survey. All courses have been depicted upon the above mentioned quad maps and are made a part of this official record. Acreage is calculated from the California State Office ArcInfo wilderness coverage.
