Data Availability

When released by the Office of Thrift Supervision, individual TFRs are first posted on the FDIC web site the Friday following the tenth day after quarter end. The available reports are updated on the FDIC web site every Friday. The final update takes place approximately 150 days after quarter-end. All data items are available on an aggregate basis and are posted to the OTS web site approximately 60 days after quarter-end.

Major Series Changes

Beginning September 2006, four new items added and seven items were discontinued.

Beginning March 2006, one new item added.

Beginning September 2005, twelve new items added.

Beginning June 2004, five items discontinued.

Beginning March 2004, one hundred twenty seven new items were added and forty three items discontinued.

Beginning March 2003, one new item was added.

Beginning March 2002, ninety-nine new items were added and 4 items were discontinued.

Beginning March 31, 2001, fourteen new items were added and 96 items were discontinued.

Beginning March 31, 1998, sixteen new items were added and nineteen items were discontinued. Twenty nine captions were changed.

Beginning March 31, 1997, one hundred forty-eight new items were added and thirty-eight items were discontinued.

Beginning June 30, 1996, twenty-one new items were added and two hundred sixty one items were discontinued.

Beginning March 31, 1995, thirty new items were added and fourteen items were discontinued.

Beginning March 31, 1994, twenty-seven new items were added and eighteen items were discontinued.

Beginning March 31, 1993, four hundred seventy-one new items were added due to the conversion of Schedule MR (Maturity Rate) to fully consolidated report referred to as Schedule CMR (Consolidated Maturity and Rate) and twenty-eight items were discontinued.

Beginning December 31, 1992, no new items were added and one hundred thirty-five items were discontinued.

Beginning September 30, 1992, three items were added and one item was discontinued.

Beginning September 30, 1991, nine items were added and two items were discontinued.

Beginning September 30, 1990, two items were added.

Beginning June 30, 1990, two items were added.

Beginning March 31, 1990, a great change was made to the S&L report, 329 items were added and 153 items were discontinued.

Beginning June 30, 1989, 106 items were added in Section H, two items were added in Section K and 201 items were discontinued.

Beginning March 31, 1989, seventy items were added and 28 items were discontinued.

Beginning June 30, 1988, thirty-five items were added and eight items were discontinued.

Beginning March 31, 1988, two items were added.

Beginning September 30, 1987, five items were added.

Beginning June 30, 1987, two items were added.

Beginning January 31, 1987 through December 31, 1988, a subset of MDRM items were reported monthly, non-quarter month end basis.

Beginning January 31, 1990 through December 31, 1992, a subset of MDRM items were reported monthly, non-quarter month end basis.

Beginning March 31, 1986, seventeen items were added.

Beginning December 31, 1985, four items were added and ten items were discontinued.

Beginning June 30, 1985, twenty-four items were added.

Beginning March 31, 1985, thirteen items were added.

Beginning March 31, 1984, the Report of Condition and Income for S&L's became a quarterly report, prior to this date it was a semi-annual report. Also, three hundred and seventy-seven items were added.

Beginning December 31, 1983, six items were added for deposit and savings account balances.

Beginning June 30, 1983, six items were deleted for deposit and savings account balances.

Beginning December 31, 1982, twenty-seven items were added and eighteen items were deleted.

Beginning June 30, 1982, two items were added.
