VISA REQUIREMENTS FOR MAURITIUS

- A. 1. Visitors are permitted to land for a stay not exceeding six months provided they have in their possession a valid passport duly visaed, return or onward passage tickets and adequate funds.
 - 2. No visa is required by holders of British passports being "Citizens of the United Kingdom and Colonies, nationals of Australia, Antiqua, Bahamas, Bangladesh, Barbados, Belgium, Belize, Botswana, Canada, Cyprus, Denmark, Dominica, Fiji, Finland, France, Gambia, German Federal Republic, Ghana, Greece, Grenada, Guyana, Iceland, India, Ireland (Rep. of), Italy, Jamaica, Japan, Kenya, Kiribati, Lesotho, Luxembourg, Malawi, Malaysia, Maldives, Malta, Nauru, Netherlands, New Zealand, Nigeria, Norway, Pakistan, Papua New Guinea, Samoa (Western), Saudi Arabia, Seychelles, Sierra Leone, Singapore, Solomon Islands, South African Republic, Spain, Sri Lanka, St. Lucia, St. Vincent, Sweden, Switzerland, Tanzania, Tonga, Trinidad & Tobago, Tunisia, Turkey, Tuvalu, Uganda, United States of America, Vanuatu, Zambia, Zimbabwe and by passengers continuing their journey to a third country by the same plane.
 - 3. Nationals of all other countries require a visa to enter Mauritius.
 - 4. Issuance of visa requires at least 48 hours.
 - 5. No fee is claimed for issuance of visa.
 - 6. Application form should be sent with (a) passport, (b) a self-addressed stamped envelope, and (c) proof of possession of ticket covering return to point of departure or onward destination (certificate from travel agent).
