# 2005-2006 Independent/Married Verification Statement

If you did not keep a copy of the tax return, request a copy from your tax preparer or a 8050c transcript from the Internal Revenue Service by calling 1-800-829-1040. The transcript must be signed by the appropriate filer(s) or signed/stamped by the appropriate IRS regional office. Please **do not** include schedules, W-2s, or attachments unless specified by our office. If you filed a 1040 for example, please only mail signed copies of the first two pages.
- Complete and sign this Verification Statement. *Incomplete Statements will not be processed.*
- Submit the Verification Statement and your *signed* tax forms to our office at the above address.
