

Receive IMLS Grant to Conduct Analysis of Catalog Records

The Institute of Museum and Library Services (IMLS), an independent Federal grant-making agency dedicated to creating and sustaining a nation of learners by helping libraries and museums serve their communities, awarded a National Leadership Grant of \$233,115 to the University of North Texas-Texas Center for Digital Knowledge (TxCDK) for a project

investigating the coding of information in catalog records from the OCLC WorldCat database. TxCDK Fellows Dr. William E. Moen and Dr. Shawne D. Miksa are the Principal Investigators of the project entitled MARC Content Designation Utilization: Inquiry and Analysis. SLIS Ph.D. student Serhiy Polyakov and Master's students Amy Eklund and **Gregory Snyder** serve as Research Assistants.

Dr. Samantha Hastings, SLIS Interim Dean, describes this project as "just the type of funded research that leads to core development in our field...the first of its kind that will be an important contribution to what we know about how content in library catalogs is actually being coded for organization and access. How the information is organized directly influences how people get the information they need."

During the course of the 2-year project, Drs. Moen and Miksa will investigate the extent of catalogers' use of MARC 21, the mark-up language used by catalogers worldwide to create electronic catalog records. The Online Computer Library Center (www.oclc.org), a nonprofit computer library service and research organization, initially agreed to supply one million records for this project. After recent discussions, OCLC agreed to provide the project with all of its approximately 55 million bibliographic records. This new development will significantly increase the accuracy of the research results. The OCLC WorldCat database contains unique bibliographic records shared by more than 50,000 libraries in 84 countries and territories around the world.

MARC fields accounted for 80% of all utilization. These preliminary findings have important implications for library catalogers, standards developers, and people involved in the machine generation of metadata.

Dr. Miksa describes how this project will provide research strategies to examine MARC records as artifacts of the cataloging process. She emphasizes that resulting data will greatly inform cataloging education and curricula which is critical to the continued development and improvement of information retrieval systems in libraries worldwide.



Dr. Jiangping Chen

Dr. Jiangping Chen joined the SLIS faculty in Spring 2004 after receiving her doctorate

in Information Transfer from Syracuse University in December 2003. She has a number of research projects underway including cross-language information retrieval, automatic question answering, and Chinese natural language processing. For her dissertation proposal, she was the recipient of the 2003 American Society of



With the support of the School, Dr. Chen conducted research on Automatic Question Answering in 2004. She developed an automatic question answering system called EagleQA and participated in TREC (http://trec.nist.gov) 2004 QA track evaluation. It was the first time that UNT had participated in TREC QA evaluation. The EagleQA system performed above the median among the 28 participating groups world wide, which was quite impressive for a first-time participant. The UNT performance on definition questions (test questions requiring a definition of a person or a particular object/event) was ranked fifth, and the performance on list questions (test questions that asked for multiple answers from multiple documents) was ranked eighth among the 28 participating systems.

Dr. Chen received a UNT Junior Faculty Grant and Summer 2005 Fellowship to continue her research on Cross Language Information Retrieval and Automatic Question Answering. She also received the Learning Enhancement Grant from the Center for Distributed Learning (http://www.unt.edu/cdl/about_cdl) to move SLIS 5970, Database Modeling and Design Information Professionals, to distributed format. The course will become a formal catalog course in 2006 with a new course number, SLIS 5707.

Dr. William Moen and Dr. Chen submitted a proposal to the Association of


> American Publishers to build a Web database in response to their distributed format. The proposal has been approved and the project is in progress. The database will serve as a connection between authors

The Journal of the Technology has accepted for titled "A Lexical Knowledge

Another paper, co-authored with Anne Diekema titled "Experimenting with the Automatic Assignment of Educational Standards to Digital Library Content," has been accepted by the 2005 ACM/IEEE Joint Conference on Digital Libraries (http://www.jedl2005.org), a peer-reviewed conference. At the 2005 **Texas Library Association Conference** she gave a presentation titled "Establishing Your Own Knowledge Base for Reference Services."

Dr. Chen, who was born in Hubei, People's Republic of China, received the B.S. in Information Science in 1988 from Wuhan University and the Master's in 1995 at the Information and Documentation Center, Chinese Academy of Science, in Beijing. We are truly fortunate that Dr. Chen chose SLIS as her new home. #

Cathy N. Hartman and Dr. Samantha Hastings Receive Grant



The Library of Congress' National Digital Information Infrastructure and Preservation Program (NDIIPP) has announced that the University of California's Digital Library, in partnership with the University of North Texas and New York University, are to receive \$2.4 million in funding to identify, collect, and preserve digital materials within a nation-wide digital preservation program. Cathy Nelson Hartman (MS '91), Head of Digital Projects, UNT Libraries, and Dr. Samantha Hastings of the SLIS faculty, are the UNT Investigators.

The three partner institutions will assess the needs of researchers, curators, and data owners, and develop Web archiving tools for use by libraries to select, capture, curate and preserve collections of Web-based government and political information. UNT will lead the Content Identification and Selection path by creating assessment tools and using the resulting data to develop a common collection-planning framework—a set of collection development guidelines that are extensible for use by a broad range of users to assess and collect Web materials.

The Library of Congress is leading this massive digital preservation program to help ensure that the students, historians, and lifelong learners of tomorrow will be able to study these subjects with the same degree of comprehensiveness and reliability that historians of the past enjoyed when they were studying less ephemeral analog materials. The awards totaling more than \$14.9 million were made to eight institutions and their partners, with matching funds provided by the recipient institutions in the form of cash, in-kind, or other resources. Paul Kruse 1912-2003

Dr. Paul Kruse, a member of the faculty from 1965 until his retirement in 1977, died in Seattle in November 2003. During his tenure at SLIS, he taught courses in reference, administration, special libraries, and history of books and printing. As a practitioner, he held positions in Jacksonville, Florida, Golden Gate College, and several other locations. In 1962-64 he received a Fulbright Grant to serve as a library advisor at the University of

Teheran, Iran; the following year he was a lecturer at the library school of the University of Ceylon. In 1968, he was library consultant at Universidad Santa Marion de Antigua, Panama, under a grant from the U.S. Agency for International Development. Dr. Kruse received the B.A. degree from John Fletcher College, the B.S. in L.S. from the University of Illinois, and the Ph.D. degree from the University of Chicago.

SLIS History Now Available

How far we have come! In eight decades, education for librarians and information scientists at the University of North Texas progressed from three courses focusing

on the practical use of books and libraries, library organization, and administration, taught by the librarian, Mrs. Pearl McCracken, in 1925, to becoming one of the outstanding schools not only in the State and Nation, but internationally as well. With an enrollment well over 1,000, the current faculty of 16 offer programs in school media, medical and legal informatics, information organization, information systems, digital image management, storytelling and youth librarianship, academic and public librarianship, and administration. Between 1996 and 2004, this diverse and talented group brought over \$4 million into the School through grants. With over \$3 million in endowments, resulting largely from the success of the Capital Campaign conducted by alumni and friends of the School in the early years of the 21st Century, the School can continue its stellar performance as a leader among professional schools throughout the country. The exciting story of how all this came about is related in text and brief historical notes.

The new version brings the text and other sections up through 2004, when the School turned 65. In addition to revisions and updating, some 40 photographs have been added. In addition to the text covering the School's history under the administration of nine directors and deans, there are added historical notes highlighting events and "firsts", a listing of deans, a roster of faculty, and lists of Outstanding Alumni Awards and Outstanding Student Awards.

The School's brief history, first compiled by Emeritus Professor Margaret Irby Nichols in 1989, in celebration of the School's 50th anniversary, and updated in 1999 by Margaret Irby Nichols and Dr. Herman Totten, has again been revised and expanded. The compilers relied heavily on reports and other materials prepared by Deans Dewey E. Carroll, Raymond Von Dran, and Philip Turner, and on information contained in *Call Number*. Others who assisted with the project include Drs. Samantha Hastings,

Philip Turner, Herman Totten, Ana Cleveland, and Donald Cleveland, as well as Melody Kelly and Jurhee Curtis.

Copies of the updated history, School of Library and Information Sciences, A Brief History, 1939-2004, were distributed to those attending the reception at the Texas Library Association Annual Conference in April 2005, and mailed to many others. TxCDK Update



One of the functions of the Texas Center for Digital Knowledge is to provide input and resources to maintain and enhance the Interdisciplinary Ph.D. Program in Information Science. In order to further this function, TxCDK and SLIS have established an Advisory Committee for the IS Doc program. The Advisory Committee consists of the TxCDK Director, who serves as chair, a group of members drawn from the ranks of the TxCDK Fellows and the Information Science faculty, with the Associate Director and Coordinator of the IS Doc program serving as ex-officio members. The Committee also assists in the review of new applicants.

Dr. Philip Turner Assumes Role As Vice Provost For Learning Enhancement

Since arriving at SLIS as Dean in 1996, Dr. Phil Turner also served concurrently as Associate Vice President for Distance Education until July 2004. At that time, per the request of UNT President Norval Pohl, he assumed the position of Vice Provost for Learning Enhancement. Dr. Samantha Hastings has

been serving as Interim Dean of SLIS while a national search is underway for a permanent dean.

In addition to attending to the details required in administering the largest elearning program at a Texas public higher education institution, Dr. Turner is involved in some very exciting initiatives. His favorite is the Blended Learning Project in which faculty are involved in transforming five large enrollment undergraduate courses. These courses will be taught as both faceto-face and blended in the fall of 2005. "The challenge," stated Dr. Turner, "is to decide which is best taught in a physical context and how that context should be arranged, and what is best taught in the virtual environment." The faculty and instructional consultants meet monthly for a working lunch as they share their journey toward blended learning. To learn more about this project, see http://www.unt.edu/cdl/blendedlearning/ Agnes Goz Pearcy, a student in the Interdisciplinary Ph.D. Program in Information Science, is working with the faculty in evaluating the outcomes of these courses as the topic of her dissertation.

Other initiatives include the implementation of a new Outstanding Online Teaching/Courseware Award. This award includes a \$500 recognition for the best online course teaching and/or courseware and also creates a process in which excellent teaching and course development can be recognized.

While his work as Vice Provost for Learning Enhancement is a university-wide effort, Dr. Turner hopes that benefits will accrue directly to SLIS. A good example of

this is UNTeCampus.com, which is a portal to information about online courses at UNT. Because SLIS has such a large number of students who rely on online courses for their program, this campus wide tool is especially beneficial to SLIS students. It has become for many SLIS students, the most important single

source for course information.

While increasing the focus on his leadership role in the use of emerging technologies in teaching and learning at UNT, Dr. Turner is still very much connected to SLIS. "I insisted that I would be able to continue my connections with SLIS students," Dr. Turner said. He continues to teach SLIS 5000, Introduction to the Information Professions, in the spring and summer semesters to SLIS entering students and to the entering cohort students each fall. He loves the excitement of the entering classes, especially at the dinner the night before the Web Institute when students from all over meet for the first time.

The many students who take SLIS 5080, Research Methods and Analysis, feel Dr. Turner's teaching influence, since it is his courseware that is used in this class. He also teaches this class each summer to the students in the Nevada or Minnesota Cohort as well as serving as the advisor to the vast majority of those cohort students. Dr. Turner also administers the Nevada and Minnesota Web Institute Programs.

His other SLIS activities include serving as Principal Investigator in two funded projects, <u>LE@D</u> and the Rio Grande Initiative, both IMLS-funded initiatives. He also works with Dr. Ana Cleveland in the Health Informatics IMLS Project. He is very excited to see the impact on the "real world" of librarianship that these projects are making.

"I am enjoying my new position very much," Dr. Turner said, "but I am delighted that I can still stay involved to such an extent with SLIS." *



Dr. Shawne Miksa Checks Out Cataloging Practices

Dr. Shawne Miksa has received \$14,700 from OCLC/ALISE Library and Information Studies Research Grant to conduct a survey of cataloging tools and resources within technical service departments of North Texas public libraries. The 73 public libraries in the North Texas Regional Library System (NTRLS) are serving as the initial sample for this project. The idea for the study arose from the desire to understand the realities of everyday operations of a cataloging department and how those realities intersect with the state of cataloging practice and education as it is reported in the library and information science literature. The idea comes also from an educator's need to prepare new catalogers for real-time cataloging, but who is continually frustrated when faced with the inability to send both local and distance students to their own local libraries to observe or even borrow cataloging tools. With the demand for webbased cataloging courses on the rise, the ability to supplement course materials with hands-on experiences is critical to the success of both the student and instructor.

CTR-NT (Cataloging Tools and Resources-North Texas) will attempt to put into motion processes to address these important broader issues by instigating a study with the local cataloging environment of these North Texas public libraries. Doctoral students **Barbara Schultz-Jones** and **Toby Faber** are serving as research assistants.

The research will address the following questions:

- How comprehensive are the cataloging resources and tools found within the technical services departments?
- What is the level of utilization of these tools and resources by staff, both professional and paraprofessional?
- How are currency and reliability of the tools and resources determined?
- How often are staff trained or updated in the use of these tools and resources?

 What factors, such as budgetary and staff limitations, affect the availability of these tools and resources to the libraries?

A comprehensive survey, follow-up interviews with select libraries, and two focus groups will be conducted. The focus groups were held at the Texas Library Association Annual Conference in Austin, Texas, in April. Results of the survey and interviews will be presented and discussed.

Dr. Miksa hopes the results of this regional study will serve, in the absence of any such tool to date, as a necessary benchmark for catalogers responsible for the quality control of library catalogs. In essence, it will lead to the creation of a list of cataloging resources and tools that every technical service department should possess. Such a list would help ensure a level of consistency in library cataloging across the board, especially if disseminated and endorsed by such institutions as OCLC or by organizations such as Association of Library and Information Science Educators, the American Library Association, or the Library of Congress. A library science scholarship honoring Dr. Kenneth L. Ferstl, a long time member of the SLIS faculty, has been established. Students who took his courses in cataloging and classification, public libraries, adult services, and services to the aging during the 1970s, 1980s, and until the mid-1990s, remember him fondly, especially for his wonderful sense of humor.

Ken, a Wisconsin native, came to North Texas in 1959 as an undergraduate student, where he earned a bachelor's degree with a double major in library science and music education. Graduate degrees in library science were added to his credentials with an MLS from the University of Wisconsin-Madison and a Ph.D. from Indiana University-Bloomington. He returned to SLIS in the 1970 and taught for more than 20 years. His teaching career ended in 1994 after he suffered cerebral aneurysms and a stroke. In his recovery, he has volunteered at the Denton Public Libraries and remained active in the Texas Library Association.

Ken and his wife **Sondra** continue to reside in Denton. They travel frequently, especially to Santa Fe during opera season. Sondra, who holds the Ph.D. in French from University of Wisconsin-Madison, taught at UNT in the Department of

Foreign Languages for a number of years. In the early 1980's, she moved to staff positions at the UNT Office of the Dean of the Graduate School and the Office of Research & Academic Grants. She concluded her career in research administration at Texas Woman's University where she was Associate Dean for Research for 15 years until her retirement in 2003.

On April 7, Ken and Sondra Ferstl, along with 2005 Outstanding Alumni **Brandon Quarles**, were honored at a champagne reception held during the TLA conference in Austin. Ken and Sondra were also recognized at the alumni reception when their photograph for the SLIS Wall of Honor was unveiled.

Victoria Kravchyna Recognized By UNT President Pohl at Commencement

At each graduation ceremony, UNT President Norval Pohl has established a tradition of recognizing students of outstanding achievement in their road to an education. One of the students recognized at the fall 2004 cere-

Victoria grew up in a small farming village of 800 people in the central part of Ukraine called Moldovka. She earned an undergraduate degree in education in her native country. During the collapse of the Soviet Union in the 1990s, Vika, as she likes to be called, found herself a single mom, living at home with her mother and sister, working a library job in Ukraine that barely covered living expenses for her and her son, Misha. That experience led Vika to believe that education could open the door

to a better life, so she applied for and won a \$50,000 information agency scholarship that brought her to Louisiana State University to earn her master's degree in library and information science.

Leaving everyone

she knew in Ukraine, Vika finished the degree in two years, while working to send money back home to support her family. She then came to UNT with a fellowship for a certificate in digital imaging management in SLIS. With diligence she worked that into an information science doctoral program. Before beginning the program, she returned to Ukraine to bring her son Misha back with her to Denton. "This day," said President Pohl, "her graduation is as much for Misha as for Vika. He took on a host of adult responsibilities to support her, and he's spent so many days in class with her that she believes he's entitled to a portion of the degree. The people in Vika's village view her as a true hero and are proud and amazed at her accomplishments." *

Christopher Childs, student speaker for the May 2005 graduation convocation, made a number of stops before ending up in the MS program at UNT. He was born

in New Jersey, grew up in several states along the east coast, went to college at Louisiana Tech University, graduated from Purdue, and worked for a bank in Indiana and a medical billing company in Virginia. When he decided to return to school, and was not certain of an educational objective, a friend suggested he volunteer at a library for at least six months to see whether he might be interested in a library career. The genealogical research that he did in the Richmond Public Library as a volunteer appealed to him, but public library work did not. In researching universities offering accredited library and information science programs, he discovered the SLIS Health Informatics program that did have an appeal. During his time in the MS program at SLIS, he served as vice-president and president of the Library and Information Science Student Association (LISSA), and for his internship, he worked on the Go Local Program for the National Library of Medicine.

Word is being spread through the Newberry Library in Chicago about the MLS program at SLIS. When asked "Why Texas?" for a "staff spotlight" in the Library's newsletter, Program Assistant Elizabeth Darocha with the Newberry Library Center for Renaissance and a current student in the master's program, replied, "It's actually more convenient to go to Texas than to UIUC (University of Illinois campus in Chicago), as I'm not required to visit campus as often." She further explained that she is required to spend only two weekends at UNT/SLIS over the course of an estimated year-and-a-half of study, and that she received a scholarship that grants her in-state tuition. Elizabeth says she was initially doubtful about claims that the online program (consisting of discussion boards, weekly online chats, and intensive reading and writing assignments) promoted a well-rounded approach to the curriculum. Now, however, she agrees with the dean who told her these would be the most

interactive courses that she would ever take. Elizabeth, who has a master's degree in art history from the School of the Art Institute of Chicago, enrolled in the SLIS digital management program of study to prepare for a future career at an art museum. *

Receives Honors

Kim Charlson, who received the master's degree from SLIS in 1984, has received two recent honors. In spring 2004, she was inducted into the Massachusetts Library Association Hall of Fame, and in spring 2005, she was named a Library Journal Mover and Shaker. Kim is known nationally and internationally for her expertise in library services to those with disabilities, Braille literacy, adaptive technology in libraries, and information access, is director of the Braille and Talking Book Library at the Perkins School for the Blind, Watertown, Massachusetts.

Blind since childhood, Kim is a Braille reader and avid user of talking books. She chose librarianship as a career, she says, because she wanted to be "in a decision-making capacity in the library field and influence the direction of library services to people

with disabilities." Through her work at Perkins, she provides librarians with a model of exemplary service to the blind and visually impaired. Her library, which services more

than 18,000 patrons, circulates more than 500,000 items each year: recorded books, Braille books, and described videos (mainstream films with a special audio track describing the visual content). Borrowers can search for and order reading materials through the library's online catalog, and through the website, borrow playback equipment, ask reference questions, and request staff to record or make Braille copies of specific titles.

Kim is the only library director in the United States who happens to be blind. Her husband says she is "all libraries, dogs, and Braille." She joins four other SLIS graduates and students who have been named as Library Journal's Movers and Shakers, Corinne Hill (MS '95) and Cathy Hartman (MS '92), who received the honor in 2004, and Michael Stephens, one of our IMLS sponsored doctoral students and Miriam **Rodriguez** (MS '97) who along with Kim, are 2005 Movers and Shakers (see p.22). *

Library Journal Movers and Shakers

Library Journal Movers and Shakers are selected from the more than 150,000 librarians in the United States and Canada now affiliated with public, academic, school, legal, medical, corporate, and institutional libraries. The honorees are cited for their innovative, often unheralded achievements advancing library sciences to a broader public. The 51 Movers and Shakers chosen in 2005 include 33 women and 18 men. Three of those chosen this year are SLIS students or graduates. They join two other graduates, Corinne Hill and Cathy Hartman, who received the honor in 2004.

Michael Stephens, one of ten students awarded an Institute of Museum and Library Services grant in the SLIS Interdisciplinary Ph.D. Program, First Year Cohort,

is head of Michael Stephens Networked Resources

Development and Training at St. Joseph (Indiana) County Public Library. He also serves as adjunct faculty member teaching the required computer technology course to library school students at Indiana University-South Bend. When St. Joseph County became the first public library to offer internet services, Michael learned that he had a knack for technology as well as teaching people how to use it. When word spread about how effective and entertaining his training sessions were, he became a popular workshop presenter. He also teaches through his web log, Tame the Web (www.tametheweb.com.ttwblog). His MLS degree is from Indiana University. (see p.11 for more information about Michael)

Miriam Rodriguez, who received the MS from SLIS in 1997, is Multicultural Services Coordinator at the Dallas Public Library, the first librarian to hold that position. A native Cuban, Miriam, her engineer husband, and children arrived in Texas in 1983. At first she worked in a bakery and later at the Small Business Development Center. Through someone she met in the latter location, she was hired by the Dallas Public Library to work mainly with Spanishspeaking patrons, which eventually lead to her enrollment in SLIS. Librarianship, Miriam

notes, addresses the many challenges new Americans face."I want to make the transition easier for them." she states. "Since many from other countries are not familiar with the concept of a public library, it is important to seek them out and to take the library to their neighborhoods."

Kim Charlson, director of the Braille and Talking Books Library at Perkins School for the Blind, Watertown, Massachusetts, graduated from SLIS in 1984. Kim, who herself happens to be blind, directs a library which serves more than 18,000 patrons. In 2004, she was named to the Massachusetts Library Hall of Fame.
