Other benefits of membership include the opportunity to serve on boards and committees; eligibility for scholarships and travel awards; participation in the annual membership meeting and awards presentation; and participation in a professional network recognized by mayors, city managers and council members across the state as the leader in professional education for city clerks and secretaries.

Did you know that there are 1,209 incorporated cities in Texas, and of those cities over 900 city secretaries and/or their deputies or other city officials are members of TMCA? And of the over 900 members, **543** are Texas Registered Municipal Clerks! To me that says cities are recognizing the benefits of TMCA membership for their city clerks and supporting their clerks through TMCA membership and TRMC certification.

What do *YOU* receive from your membership in TMCA, Inc.?

The mission of TMCA is to provide an educational and professional development program for municipal clerks. It has successfully accomplished this goal since 1967 when the Texas Municipal Clerks Certification Program was established at the University of North Texas. TMCCP is the educational arm of TMCA, and it exists to provide a professional development program with college/university level courses leading to certification as a Texas Registered Municipal Clerk. To me one of the greatest benefits of being a member of TMCA, Inc., is the ability to obtain the coveted TRMC!

TMCA is also an invaluable resource for professional networking and support. One of the great accomplishments during the last decade has been the creation of the TexasMunicipalClerks Yahoo! Group list serve, which was created to share information and experiences almost immediately. Before this, it used to take days to get a response to a question or hours on the phone surveying how other cities do things. Further enhancing our online presence, just this year the TMCA/TMCCP web page launched interactive features to provide exclusive information to its members, including a personal login for access to each member's TMCA membership history, TMCCP transcript, and the membership directory.

TMCA also financially supports its membership in their pursuit of professional education. For the last several years, through the generous contributions of donors and its own members, it has been possible to establish a major TMCA scholarship program that allows us to give money back to the members. Recently, we have been able to further expand the existing scholarship program through the generous donations of corporate and private sponsors. The scholarship program established by TMCA/TMCCP is a great source of pride for the leadership of this organization.

Another way the Association serves its members is through its history of producing invaluable **publications** tailored to its membership. Our oldest publication is the **Texas Municipal Clerks Handbook**, in print since 1976, and now in its eighth edition (a ninth edition is planned for 2010). I look forward to our teamwork as your 2009 TMCA President.



Behind the Scenes— TMCCP Seminars

Have you ever really thought about where your seminar dollars go when you register for a TMCCP seminar? We all know we receive quality programs in quality facilities with quality speakers at our TMCCP seminars, but most of us are not aware of the behind-the-scenes details of producing a seminar.

WHAT YOUR REGISTRATION FEES COVER

Consider that the registration fee for a seminar (other than Election Law or Graduate Institute) is \$210.00 for one person. For a TMCCP seminar with 100 attendees, approximately \$800 is spent on printing and postage to send notices to each member. Speaker fees average \$2,000 (and this doesn't include the speaker's lodging, meals, and travel). The hotel charges equipment, labor, and gratuity, for the audiovisual equipment, and these average \$1,000 for two days. The cost of handouts can range anywhere from \$650 to \$1,000. But wait—we haven't even gotten to the food!

Did you know that hotels charge up to \$55.00 per gallon for the coffee we drink at breaks? (And we thought gas prices were high!) And the sodas range from \$2.50-\$3.25 each! Typically, lunch provided for each attendee at our seminars costs about \$23.00 plus 20% gratuity. Then add muffins, fruit, pastries, and snacks, and the costs exceed \$8,000 just for food for 100 attendees at a two day seminar! Expenses for seminars such as Election Law are even greater because the larger attendance requires us to book conference hotels in metropolitan areas where the costs are higher. Each year we see increases in hotel costs in all areas due to inflation, gas prices, labor prices, food prices, and maintenance costs.

PLANNING AHEAD

Did you realize that most hotel contracts for our seminars are booked two to three years in advance? This is done in order to lock in lower sleeping room rates so you can accurately plan for the costs in your budget. To me it is very important to know the costs associated with a seminar prior to developing my travel budget, which I have to do sometimes more than a vear before the seminar! Unfortunately, we have no way of foretelling the number of attendees for any given seminar. TMCCP staff is very experienced in predicting attendee numbers based on previous history, but no one can know two years in advance what the future will hold. That is why we have experienced crowded conditions at some of our seminars. Staff books the hotels with accommodations that will best fit our needs based on previous attendance, projected membership numbers, the geographical location of the city, the subject of the seminar, and projected economic trends. Crowded conditions at our seminars don't mean poor planning—it means growing numbers and increased educational needs of our membership! I will gladly sit in a chair without a table to lean on if it means more clerks will be able to receive the educational benefits of a fantastic speaker! I am happy to wait in line for the elevator—it gives me more time to visit with friends and colleagues I haven't seen in a while. It means TMCA is doing its job!

ELECTION LAW SEMINAR MOVE

The Election Law Seminar continues to be one of our most popular and highest attended seminars and averages close to 600

attendees. Because of the growth of the seminar over the last several years, the Election Law seminar requires a hotel that can accommodate 275-300 attendees for the pre-seminar Step-by-Step session, 600 attendees for the Secretary of State session, and three concurrent sessions of 300 attendees each, not to mention the number of overnight rooms needed for those attending. TMCCP Directors Snay and Burnside visited every possible hotel in Austin that could meet the space requirements for the Election Law Seminar, but were unable to negotiate a contract that would benefit the members. Because of the increased corporate demand for hotels in Austin, most hotels would only offer to book the conference for the week of New Year's. Others would only book our conference at the corporate rate (on average, \$200/night for sleeping rooms). The TMCA Executive Board and TMCCP staff felt these options would not be in the best interest of the membership.

The Sheraton Grand Hotel DFW in Irving will be the host hotel for the Election Law Seminar beginning in January 2009. We have held several seminars at this hotel, the most recent being the Municipal Finance seminar held this past April. The hotel has two large ballrooms that will accommodate our seminar format and a huge foyer area that will make breaks easy to navigate and allow us to comfortably mill around and visit. With DFW Airport next door, travel should be convenient for everyone. Though we will miss the beautiful view of Town Lake and the ambiance of Austin, we will gain great shopping at Grapevine Mills and restaurants galore within a short distance. (Being from a small town, I still get a kick out of watching the airplanes pass right beside the window of my room

to land!) I feel confident the hotel staff will go out of their way to meet our needs. The hotel recently took their excellent service above and beyond the call of duty during extraordinary circumstances at the seminar we held at the Sheraton Grand in April. When the electricity went out at our Municipal Finance Seminar—circumstances which were beyond the hotel's control—the hotel staff did everything they could to make us comfortable and keep the seminar going; they even boiled water on a gas stove in order to have hot, fresh coffee for us the next morning! One thing is for sure, the change in venue will not change the quality of sessions or speakers for the Election Law Seminar, but will provide a more comfortable environment to learn and to network—and that's what it's all about!

From your evaluations, we have received some positive feedback on the move to Irving. Though everyone may not share these feelings, know that TMCCP staff and your TMCA Executive Board works hard to provide seminars that: facilitate learning in a comfortable environment; provide a great network for professional and personal growth; and offer a variety of activities. We look closely at the evaluations submitted after each seminar and make changes that will reflect the membership's needs. In response to comments on your evaluations, we have recently added healthier snacks for breaks and have started serving breakfast-type foods prior to the

beginning of the morning sessions. Your comments do make a difference! Be sure to fill out your evaluations or feel free speak to **Administrative**Director Peggy Burnside or a board member directly. We want and need your suggestions and feedback in order to serve you better.

SEMINAR SPONSORSHIP POLICY

In an attempt to keep seminar costs affordable for all of our members, the TMCA Executive Board recently adopted a **Seminar Sponsorship Policy** which will allow vendors to purchase annual sponsorships for the purpose of offsetting TMCCP educational seminar costs. Four levels of sponsorship are available ranging from \$1,000 to \$3,000, and sponsors will be provided with a level of recognition that is commensurate with their contribution. Qualified vendors will be allowed to exhibit at the Annual TMCCP Election Law Seminar beginning in January 2009. This policy was implemented to help TMCA/TMCCP maintain current registration fees and offset increases seen annually in hotel venue expenses. TMCCP staff and the TMCA Executive Board are very aware of the tight budgets that cities are facing, and will strive to be diligent to keep expenses down.

Administrative Changes At TMCA Headquarters

On behalf of the Advisory Management Committee (AMC), I am pleased to provide an update of changes which have taken place at TMCA, Inc., headquarters.

As some of you may know, in 2007 our Executive Director, Dr. Joyce Snay, tendered her retirement letter effective at the end of 2008. Needing to help in the care of her family, Dr. Snay began a work-from-home arrangement. The Executive Board decided to rearrange the duties of what the Executive Director had been responsible for in the past and placed some of those duties with Peggy Burnside (then the Assistant Director). The Board also named Mrs. Burnside as the Administrative Director and named Dr. Snay as the Education Director, thus doing away with the title Executive Director and creating co-directors. It was also during this time that the Executive Board directed the AMC with the task of initiating the advertising process for a new Education Director.

Prior to commencing the advertising process, I visited with both directors about the working arrangements, inquiring as to how it was working for them and the office staff. Both Director Burnside and Director Snay stated the working arrangement was extremely successful and mutually beneficial to the members and staff. Dr. Snay remains constantly available to our staff and to our TMCA members, continuing with the regular duties of an Education Director, including the grading of homework, tests, and book reports, and thoroughly evaluating the education curriculum.

Director Burnside continues as Administrative Director and is charged with oversight of the TMCCP staff and program, the TMCCP budget, seminar planning and coordinating, continuing as a liaison to UNT and TMCCP publication authors, and maintaining all records of our busy organization. She could not do this without the tremendous help of office staff members Alexandra Burke and Miriam Sheehan and our student assistant, Stephanie Taylor.

After the input from both directors and staff, I inquired whether Dr. Snay would consider staying on as the Education Director under the present working arrangement, should the Board vote approval. The Board voted to continue with the present arrangement of dual directors, and Director Snay rescinded her letter of retirement. With great enthusiasm Director Snay stated, "This is an outstanding opportunity for me. Working with the members who are pursuing the distinguished Texas Registered Municipal Clerks Certification and/or recertifying is extremely rewarding and meaningful. It is also an honor and privilege to continue to work with and for the members of the advisory management committee, executive board, office staff, and all our members. It is a joy to be a part of this professional team as we collaborate for continued success."

Our education and administrative teams continue in place, and we are the better for it. How privileged we are to have such dedicated staff.

IIMC News

Over the past year, the focus of much conversation among members, the IIMC Board of Directors, Institute Directors and staff, has been certification and the IIMC Education Guidelines adopted by the IIMC Board of Directors in October of 2006.

IIMC President Chuck Tokar appointed a Task Force of stake holders who spent many hours in deliberation resulting in eventual Board adoption of a "grace period" for certification candidates and changes to the course review process offering flexibility in reporting for Institutes, state associations and individuals. The new process encourages "pre-filing" but allows the practice of post-event filing by individuals seeking certification from IIMC and by state associations, and also allows an annual filing for institutes. This information can be viewed in more detail on the IIMC website at www.iimc.com.

At its telecon meeting of April 3, 2008, and following thoughtful comments by Executive Director Chris Shalby, the IIMC Board of Directors determined to take a big step back and begin a methodical and planned approach to discover what exactly the membership wants from its certification programs. The Task Force ably steered the membership through the two most difficult and immediately pressing issues (preapproval and grandfathering). The Board decided it was time to have a serious conversation with the membership everywhere they gather asking what these certification programs mean and what the membership wants them to be in content and form. Let's engage every member who is willing to define exactly what combination of education, professional experience and personal growth has real meaning for them personally and for the organizations they serve. In that light, on April 3, 2008, the following motion was approved by the Board:

"In support of the recommendations of Executive Director Shalby, at their meeting in Atlanta the Board of Directors shall: (a) conduct a meaningful face-to-face discussion of IIMC's mission and education programs; (b) formulate an action plan to engage the membership, Institute Directors, committees, staff, and the Board to define these programs—beginning with the membership; (c) identify any stand-alone issues that may require immediate attention (e.g., twelve MMC points per year); and (d) fold the Task Force recommendations and Director of Education reports into the Board and membership dialogue."

The IIMC Board met on May 16 at the annual conference in Atlanta and spent the bulk of its time discussing educational issues. Based upon member and state association input, the Board agreed to continue its previous decision allowing pre or post event filing for point assessment determinations and also

agreed to the following: 1) Extend the "grace period" for those who were enrolled in a certification program prior to January 1, 2007, through December 31, 2009; 2) Lower the number of points required to remain in the Master Municipal Clerk Academy from 12 points annually to 6 points annually; and 3) Immediately rescind the requirement for a Bachelor's Degree or 15 years of experience beginning in 2013 to obtain the Master Municipal Clerk designation.

The Board also discussed the need to return to the practice of placing the decisions regarding educational needs for municipal clerks in the hands of our state/provincial associations and institute directors. In that light, several members of the IIMC Board participated with our institute directors, state association presidents and state education chairs in a wonderful discussion regarding clerk education and certification at the Education Colloquium in Atlanta.

There will be a great deal more discussion and member input regarding the entire education/certification program, including member input about the benefits of seeking accreditation for IIMC through a recognized credentialing agency. Basically, IIMC members need to tell the Board if holding certification(s) from an accredited agency is important to the members, and if the members are willing to comply with certification program guidelines to make accreditation a reality. A communication on this issue will be sent to members in the future as well as an educational needs survey.

I want to encourage Texas clerks to be aware of these upcoming opportunities to engage in this process throughout the next year. This is about the future of the IIMC certification programs and the primary activity of this professional association. Let's envision a program that supports the profession in every member's office, supports our state certification programs, a process that is understood and timely, tools to ease the workload burden

To qualify for entrance into the Master Municipal Academy (MMCA), which prepares participants for achieving the MMC status, one must have earned the CMC designation. To earn the CMC designation, a Municipal Clerk must attend extensive education programs. The designation also requires pertinent experience in a municipality. The program prepares the participants to meet the challenges of the complex role of the Municipal Clerk by providing them with quality education in partnership with 47 institutions of higher learning.

The MMCA is an advanced continuing education program that prepares participants to perform more complex municipal duties. The program has an extensive and rigorous educational component, a professional and social contributions component, and a commitment to lifelong learning. The Academy members must demonstrate that they have actively pursued educational and professional activities and have remained informed of current socio-political, cultural, and economic issues that affect local governments and municipalities. **

Texas Municipal League New Member Orientation February 29, Austin

The meeting convened with board member introductions. Harvey Kronberg, editor and publisher of *The Quorum Report* in Austin, gave an assessment of the primary election and how the election results would impact major legislative issues that will be addressed in 2009. Mr. Kronberg mentioned that redistricting would play an important role during the political decision-making process.

Presentation by Officials From the City of Houston

Ms. Andrea White, Houston's First Lady, and Yolanda Alvarado of Houston, gave a summary of Mayor Bill White's high school dropout program. The program is a collaborative effort with Houston ISD. It is designed to reach out, door-to-door, to combat the problem of high school dropouts. Since the program began in 2004, more than 4,000 students have returned to school and about 200 of these students have graduated.

Mrs. White and Ms. Alvarado encouraged city participation in the program. Further details about the program will be included in the next TML *Texas Town & City* magazine.

President's Report

TML President Todd Pearson recommended a change in the TML Constitution/bylaws relating to the Board of Directors. He proposed that *all* past TML Presidents remain on the Executive Board as voting members as long as they remain in office. This change will require a vote at the TML Annual Conference.

TML Staff Reports

Texas Municipal Retirement System (TMRS) Update
