What's In Your Toolbox?

Tool: a device or implement used to carry out a particular function.

In late 2014 the TMCA board began a strategic planning process to establish a pathway for the future success of our association, education and certification programs, and our profession. A SWOT (strengths-weaknesses-opportunities-threats) analysis was conducted to clarify our organization's vision and establish the goals necessary to that end. One of the things we learned in the SWOT analysis is that although TMCA/TMCCP has legitimacy/recognition and is well established and respected, for the membership, there is a lack of assistance in how to make its skills and knowledge marketable and attractive when applying and interviewing. A perceived threat was that cities are devaluing the city secretary/municipal clerk profession.

Awhile back, I participated in a webinar that covered branding ourselves as leaders and communicating our value to others. My co-presenter was Joanne Tilton, city clerk (retired), Manteca, California. The California clerks had created an "elevator speech" to help clerks respond professionally to the question asked, "What is a city clerk, and what do you do?" Too many times the response was, "I attend council meetings and take minutes." I presented the idea for our own "elevator" speech to the TMCA board, and President Salgado asked me to head up the development of an "elevator" speech as a tool for Texas clerks to help them communicate their true value to the organization and the community. This "elevator"

Here is the latest tool for your toolbox:

"Functioning much like the Secretary of State, the City Secretary/Municipal Clerk is the local official who maintains the integrity of the election process, ensures transparency and access to city records, facilitates the city's legislative process, and is the recorder of local government history. The City Secretary acts as the compliance officer for federal, state, and local statutes, including the Open Meetings Act and the Public Information Act, and serves as the filing authority for campaign finance reports and financial disclosure statements."

This **elevator speech** can be used in any way you see fit: framed and on your desk; posted on your webpage; or printed on the back of your business cards. We hope that you find this tool useful when communicating your true worth to your council, your city, and your community.

speech addresses Strategic Initiative #4: PROMOTION OF THE PROFESSION—TMCA enhances and communicates the identity and vital role of the municipal clerk to a city's success; Strategic Action 5: Emphasize to members the important role a municipal clerk performs as an officer of the municipality. My partners in this endeavor included President Cheryl Salgado, TRMC, city secretary/assistant city manager, Spearman; Mary Kayser, TRMC, city secretary, Fort Worth; and Becky Garza, TRMC, city secretary, Lubbock. TMCA/TMCCP Education Director Dr. Amy Holt, TRMC, and Administrative Director Peggy Burnside, TRMC, also provided their input. Our draft was presented to the TMCA board at the November 2016 meeting, tweaked, and formally adopted by the board.

Apply to Serve as a Trustee On The TMCA Board of Directors

Have you ever thought about serving as a TMCA Board of Directors trustee but didn't know exactly how to apply? Well, the board has heard you, and responded by updating the nominating procedures to encourage participation from across the state chapters.

The biggest change is formally promoting the application process. Much like the committee recruitment process, the Nominating Committee will announce the annual application process for serving on the TMCA Board of Directors. The annual deadline for applications will be May 1. The new **nomination application** will be available year round on the TMCA website; however, only applications received by the deadline will be considered in that appointment year.

Application requirements were enhanced to add the following:

- Applicants must have a minimum of two years of TMCA committee service
- Mayor or city manager must formally support applicant's nomination by signing the application form
- Application must include a letter of recommendation from an active or retired city secretary or a chapter president

Please remember to consider time commitment for service on the board. The board meets four times a year—usually in March, July, October, and November. All meetings are held in Dallas with the exception of the October meeting, which is held at the TMCCP Graduate Institute

Seminar. Attendance is mandatory, and more than one absence results in automatic resignation from the board.

If you are interested in applying to serve as a trustee for 2018, please read the "Requirements for Service as an Association Trustee" for all the requirements and to learn more about the process.

This policy update is in response to Strategic Action 1, Strategic Initiative #6 of the TMCA Strategic Plan which reads, "Establish a formal trustee application process for consideration of Nominating Committee to encourage diversified representation."

Special appreciation is extended to the Nominating Policy Ad Hoc Committee members appointed by President Gibson-Salgado for their work in bringing forward the enhanced policy: Chair Norma Aguilar-Grimaldo, TRMC, city secretary, Odessa; Mary Kayser, TRMC, city secretary, Fort Worth; Susie Quinn, TRMC, city secretary, Murphy; Scarlet Swoboda, TRMC, city secretary, Victoria; Linda Byers, TRMC, city secretary, Vernon; and Shelley George, TRMC, city secretary, Allen.

2016 TMCA Clerk of the Year

Congratulations to Haltom City City Secretary Art Camacho, TRMC!



Municipal Clerk of the Year Committee Chair Brenda Shaw, TRMC, city secretary, Morton, presents the 2016 TMCA Municipal Clerk of the Year Award to Art Camacho, TRMC, city secretary, Haltom City, at the TMCA banquet.

Each year Texas municipal clerks nominate one of their peers for the prestigious state Municipal Clerk of the Year Award. To be eligible for the award, a nominee must be an **active member of TMCA**; must have **provided service to other municipal clerks** on a local level or state level; must have exhibited **leadership abilities**; must be a **Texas Registered Municipal Clerk**; and must **currently hold a municipal clerk position**. The Municipal Clerk of the Year Committee scores nominee applications on years of municipal service, years of TMCA membership, TMCCP certification/recertification achievements, TMCA service, local chapter service, special projects service, IIMC service, and participation as instructors or conveners in TMCA, local chapter, and IIMC education sessions.

For his outstanding achievements as an exemplary public servant and invaluable mentor and advocate for city secretaries, **Art Camacho**, **TRMC**, **city secretary**, **Haltom City**, was selected by the TMCA Municipal Clerk of the Year Committee as our 2016 honoree.

The TMCA North Texas Chapter nominated Art for this prestigious honor. As part of the nomination statement, Fort Worth Assistant City Secretary Ron Gonzales, TRMC, stated, "Art continually leads by example and exhibits a pattern of service to others, personally and professionally. He is a thoughtful leader, a trusted and sought-out mentor, and a wonderfully animated and generous friend. I am honored to know Art and have been fortunate to receive his counsel and wisdom on several occasions."

In his speech, Art thanked the chapter for their repeated nominations for this award, and hum-

bly lauded his fellow nominees: "Because of my longevity, I was able to acquire the needed score, but I know there are several clerks mentioned this evening who displayed all of the qualities and are deserving of such an award."

In addition to the North Texas Chapter and the TMCA Municipal Clerk of the Year Committee, Art thanked his city staff, City Manager Keith Lane and Deputy City Secretary Donna Pliska, TRMC, who he said was both his "right arm" and his "right mind." He also thanked his city council; members Walter Grow and Dr. An Truong were in attendance. Art thanked his family who were

in attendence: his sister, Cecilia Villa, and her husband Art; and his wife Robbie, "for all your support throughout the years of my city clerk service. I know there were many sacrifices you made so I could be able to acquire my certification, and also all of the 'alone' times you have spent while I was busy attending seminars and chapter meetings. And I also want to apologize for the many times you were the 'sounding board' to my frustrations that I didn't leave at the office. Even as we approach 42 years of marriage, you still have my heart and I love you very much." He also thanked his late parents, Arturo Sr. and Elisa Beth Camacho, for encouraging their children "not only to pursue education, but also to serve humanity to our fullest extent."



On the timing of this award, Art said: "I spent over 20 years in the oil and gas industry before beginning my municipal livelihood at Ranger in 1999. Six years later, I was employed at Azle until 2008, and then was hired as the city secretary in Haltom City, where I hope to finish my career.

"What is ironic about this award is that it comes off the heels of one of the toughest times I have ever encountered as a city secretary. We had a Charter Committee appointed in early 2015 that had 16 meetings to place charter amendments on a November 2015 ballot, and because of all of the new Loop 820 highway reconstruction, our Economic Development Corporation doubled the number of meetings they normally schedule. Also, due to the fact that several of our council members—elected in May 2015—were novices, they became heavily involved in all aspects of our city operations, the city budget, working with other boards and commissions, and devoting time to community involvement. Because of their commitment toward change, their meetings doubled also. I clerked 79 meetings in 2015 without missing a posting or minutes deadline and, so far, have clerked 55 meetings this year.

"On a personal note, I also suffered the loss of my dad right before Christmas in December last year. My family has been very blessed in that, prior to his passing, we have stayed intact, which really defies the odds. Adding to my even closer personal difficulties, my wife was hospitalized three times within a year and I barely avoided another heart bypass surgery because of a clogged artery on the backside of my heart. It's been tough, but even these items were not the end of my plight.

"The enigma of this award tonight is that I made my biggest mistake ever as a city clerk this last March. I made a huge error on our 2016 General Election ballot that was eventually remedied in time by our election contractor, Tarrant County, but at

a cost that would equal the annual salary of many of the clerks here tonight. Don't misunderstand me: I treat city elections very seriously. I once dismissed an Early Voting Election Judge because she was making influential statements to voters regarding a candidate. We are sworn to preserve, protect and defend the Constitution, which carries in it the provisions for an impartial and fair election process for selecting our local leaders. My dad spent three-and-a-half years of his life in a Japanese Prisoner of War camp in WWII defending this privilege, so I can't help but take it personally. But, I had made a huge error.

"My council was very gracious and we came to an agreeable situation in handling this costly oversight. I have to tell you that when the mistake was fully realized and I was faced with the duty of reporting it to my superiors—I am hired by the Council—my heart sank, my palms were sweaty, and my pulse was racing. But I dismissed this and immediately went to my city manager with the distressing news and also called the mayor. I sent each council member an email the next morning detailing the exact sequence of events leading up to this and left them with a decision to make in regard to my employment. I took full responsibility

for my actions and didn't fabricate any excuse for my mistake.

"I heard someone once say, 'To those of you beginning your career as a clerk in the TMCA program, if you can ever grasp and take hold of one definite objective throughout this whole series of instructional training you are given, it is for you to maintain the intestinal fortitude in pursuing that which is right and just, and exemplify it to your citizens, your staff, and your council daily. You may be questioned on your knowledge and experience, but don't ever let your ethics be doubted. That is the TMCA.' Oh, wait... I remember now: I said that in my TMCA presidential acceptance speech three years ago. You see, after saying that, there now came a time that I had to 'Put up or shut up'; that I 'gotta Walk the Talk.' It's easy to dictate from a speaker stand what a clerk should do in times of job adversity, but it's another thing when it's you finding yourself in a position of uncertainty. What do you do?

"I can't answer for you. I can only answer for myself. I was able to 'uphold the Code'—the Code of Ethics that we promote in our association, on the final page of tonight's program. If I, as a former TMCA president, would lie or throw my deputy secretary under the bus for my failure, I have done nothing but completely disregard the very core of the ethics of our group. It becomes a lie when you can't live it. One council member called me after the executive session was over to see if I was okay and he also stated that my honesty through this situation was a prevalent factor in the rendering of their decision.

"So I share this award tonight with all clerks who 'live it,' and each day we are challenged as to the manner in which we value our profession. But there

has to be something that drives our priorities. I don't know how each of you cope with the problems and difficulties you encounter in your city. Maybe you listen to a 'Positive Thinking' CD on your way to work. Or maybe you get to work early, close the door, take off your shoes, and then sit on your desk yoga style and repeat a mantra over and over in meditation. Whatever it is that prompts and directs you to confront your problems forward with sincerity, stay with it.

"I have a slightly different variation that helps me to stay focused and balanced. It's a little morning devotion and it works, for me at least. Because having the incentive to do the right thing didn't end for me when my role as TMCA president expired in 2014 and President-Elect Sherry Mashburn took my place. But when is it over? Is it over when this award, with its fine wood and metal engraving, finds its place on my office wall? No, it isn't over. Will it be over when, hopefully, about six years from now, you get a retirement invitation for some cake and punch and drive to Haltom City and watch Peggy and her crew give me a TMCA blue retirement blanket? No, it's still not over—not for me.

"You see, and I may be a little politically incorrect in stating this, but it will be over when I rise from a kneeling position and He wraps His nail-scarred hands around me in a deep embrace and says, 'Well done, thou good and faithful servant.' Then, for me, it's over.

"This mistake situation was tough and it wasn't easy to remedy on both sides. But if, after hindsight, there is left no doubt that honesty and integrity is the most vital part of my city secretary department and our actions guarantee this, then I wouldn't have it any

other way. I want to implore this mindset to each of you clerks tonight because where you are, where you work, and where you serve your citizens, you are your city's 'Clerk of the Year.' There is no one else filling this position.

"Thank you again for selecting me to receive this prestigious award. I will always treasure this because I have always had a passion for TMCA and I hope to forever exemplify the standards of our profession, even when I no longer am sitting behind a city clerk's desk."

Art Camacho has served the citizens of Haltom City as city secretary since 2008. Prior to that, he served as city secretary of the City of Azle from 2005 to 2008, and as city secretary of the City of Ranger from 1999 to 2005. He received his Texas Registered Municipal Clerk certification in 2003 and is enrolled in his third recertification. Art has also received his Certified Municipal Clerk designation from IIMC.

Throughout his 17 years as a municipal clerk, Art has been very active and enthusiastic about the his profession. He served as TMCA president in 2014, previously serving as trustee and in every officer position on the TMCA executive board since 2007. 
