# PSCI 1041: Honors American Government–Laws and Institutions Fall 2016 TR 9:30–10:45 AM, Sage 355

The purpose of this course is to introduce students to the roles of the United States and Texas governments in the American political system. We will consider the institutions, processes, and decisions of political actors that define American and Texas government. We focus particular attention on the United States and Texas constitutions, civil rights and liberties, federalism as well as the institutions that comprise the three branches of government.

# **Course Materials**

1. A college-level American government textbook

All students will need a college-level American government textbook. The bookstore will have Barbour and Wright's Keeping the Republic, 6th Brief Edition in stock if you want to purchase that one. The ISBN is 9781483381138. If you have another college-level American government textbook from another class or can borrow one from a friend that has taken PSCI 1040/1041 or PSCI 1050/1051, that is fine.

If you are borrowing a book from someone else, make sure that it isn't a custom edition for PSCI 1050/1051; if it is, it probably won't include the information that you need.

An off-the-shelf college-level American government textbook from a reputable publisher will be fine. Some good publishers include Pearson, CQ/Sage, Wadsworth/Cengage, McGraw-Hill, and Soomo. Post in Piazza or bring a borrowed book to class if you'd like me to verify that a title is appropriate.

# **Assignments and Grading**

All assignments and exams in the course will be assessed as Satisfactory / Unsatisfactory, with the specifications required for Satisfactory articulated on each assignment. In general, Satisfactory should not be viewed as "minimally competent," but rather as a mark of having achieved the assignment's learning goals and specifications. An assignment meets the goals, or it does not—there is no gradation of assessment. The only letter grade that will be given in the course will be your final grade, and it will reflect the "bundles" of assignments and requirements you have satisfactorily accomplished in the class. That final letter grade is not an assessment of your intelligence, your abilities, or your value as a person. Rather, the grade reflects what you demonstrated that you learned in the course: no more, no less.

Built into this system is a good deal of choice as to how much you wish to learn and how hard you want to work to demonstrate and apply that learning. You might choose that passing the course with a C is sufficient for your goals—it is perfectly appropriate and worthy of respect for you to make that choice, especially if it allows you to proactively allocate your time to other endeavors. If you strive to get an A in the course

and maximize your learning, you should know that you are taking on that work and challenge yourself, and should make sure you are in a personal and academic situation to achieve that level of engagement.

#### Exams

There will be two exams in the course. Each exam will consist of two sections—a Basic Section and an Advanced Section.

#### • Basic Section

- Will include questions that require students to remember, understand, and apply course material.
- Question types will include a combination of multiple choice, multiple answer, true/false, matching, and ordering questions.
- The Basic Section of each exam will be administered as a closed-book/note test during a regularly scheduled class meeting.
- In order to Satisfactorily complete the Basic Section of an exam, you must earn 70% of the available points.

## Advanced Section

- Will include questions that require students to analyze, synthesize, and evaluate information using course material.

- Question types will include a combination of multiple choice, multiple answer, true/false, matching, ordering, and short essay questions.
- The Advanced Section of each exam will be administered as a take-home, open-book/note test.
- In order to Satisfactorily complete the Advanced Section of an exam, you must submit the exam on time and earn 80% of the available points.

#### **REEF Polling**

During every class period students will be presented several questions using REEF polling. To earn a grade of A or B in the course, students must earn at least 85% of the available REEF points. To earn a C, students must earn at least 70% of available REEF points.

#### Quizzes

I will give announced and unannounced quizzes during the semester. Unannounced, in-class quizzes on assigned readings may be given any time you have a reading assignment. These quizzes are closed book, but you may use notes that you have taken on the assigned readings as long as they are printed in hard copy. (You cannot use a laptop, tablet device, or phone during quizzes.) Some quizzes will be announced ahead of time and may be completed outside of class time. Occasionally, unannounced or announced in-class activities may be administered for quiz points. Missed quizzes and in-class activities cannot be made up.

# Reflection Essays

Students completing the A, B, and C bundles are required to write a number of reflective essays. These reflective writing assignments ask you to think about course concepts and the ways in which they apply to your life and/or to contemporary political debates. Some reflection prompts are classified as *experiential*; these prompts require you to attend, watch, or listen to an event and then reflect on what you witnessed. For each grade bundle, half of the required reflection essays must respond to experiential prompts. Students may only submit 1 reflection essay per week.

To earn credit for a reflection essay, (1) the essay must be submitted in Blackboard as a Word or PDF document; experiential reflections must be submitted within 7 days of the observed event, (2) the response must address all components of the prompt, (3) the response must be a minimum of 375 words, and (4) the response can include no more than 3 grammatical or spelling errors per page (250 words).

# Identifying Plagiarism Assignment

All students must complete an online certification verifying that they are able to recognize various forms of plagiarism. Detailed instructions are posted in Blackboard.

#### **Debate-Related Assignments**

Students completing the A, B, and C bundles will lead a class debate on a proposed reform to the American political system. The remaining assignments in the course are related to these debates.

- Annotated Bibliography Assignment (required for A, B, and C bundles)
  Students will identify academic resources to construct arguments to support their assigned position and to rebut opposing arguments. This assignment requires students to identify appropriate resources and summarize the authors' arguments in their own words.
- *Debate Paper Assignment* (required for A and B bundles)
  Students will write an 8–10 page research paper on their debate topic.

- Debate Preparation Assignments (Required for A, B, and C bundles)
   To ensure the class is prepared to evaluate and participate actively in the Q&A portion of each debate, students are required to complete a number of debate preparation assignments prior to the in-class debates. (The C bundle requires 1 debate preparation assignment. The B bundle requires 2 debate preparation assignments.)
- In-Class Debate Assignment (Required for A, B, and C bundles)
  In most cases, students will work in teams of two for the debates. I will assign teams, topics, and perspectives (pro/con) by Tuesday, October 4. Details about debate logistics will be discussed in class and the criteria for evaluation will be posted in Blackboard.
