INSTRUCTIONS FOR COMPLETING TEXAS MOTOR FUEL TRANSPORTER REPORT

WHO MUST FILE

Every motor fuel transporter transporting gasoline or diesel fuel in Texas by truck, railroad tank car, or marine vessel. Failure to obtain a license with the Comptroller or file a required quarterly report may result in the assessment of civil penalty as prescribed by Chapter 162 of the Tax Code.

A motor fuel transporter license is not required for a person transporting their own fuel in their own cargo tank for their own use and not for resale.

WHEN TO FILE

This report must be filed on or before the 25th day following the end of a calendar quarter for gasoline or diesel fuel transported during the preceding quarter.

- TYPE or PRINT.
- Complete all applicable items that are not preprinted.
- If any preprinted information is not correct, please mark out the incorrect information and write in the correct information.
- ROUND ALL GALLONAGE FIGURES TO WHOLE GALLONS.

- Item 1-** Complete the "Texas Schedule of Motor Fuel Transporter Deliveries--Exports", (Form 06-134), to obtain the necessary information for this item and attach the schedule to this report.

- Item 4-** Enter the combined total gallons lost by fire, theft, spillage, or accident.
