This form is used to:

- Obtain a computer printout, which provides the current owner/lien holder name, address, vessel/boat and/or outboard
 motor description. The form PWD 763 must be completed and submitted with appropriate fees to TPWD Headquarters in
 Austin, a TPWD local law enforcement office, or a participating County Tax Assessor-Collector office.
- **Obtain the History**, which provides a copy of all documents submitted for transactions on file for a vessel/boat and/or outboard motor. TPWD retains historical documentation for vessels and outboard motors for a period of 10 years. The form PWD 763 must be completed and submitted with appropriate fees to TPWD Headquarters in Austin.
