<b>Monday, February 12, 2007</b>  <i>Deadline extended because of weekend.</i>	<b>February monthly activities report</b>  (all lobbyists filing monthly)	January 1, 2007	January 31, 2007
<b>Monday, March 12, 2007</b>  <i>Deadline extended because of weekend.</i>	<b>March monthly activities report</b>  (all lobbyists filing monthly)	February 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	February 28, 2007
<b>Tuesday, April 10, 2007</b>	<b>April monthly activities report</b>  (all lobbyists filing monthly)	March 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	March 31, 2007
<b>Thursday, May 10, 2007</b>	<b>May monthly activities report</b>  (all lobbyists filing monthly)	April 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	April 30, 2007
<b>Monday, June 11, 2007</b>  <i>Deadline extended because of weekend.</i>	<b>June monthly activities report</b>  (all lobbyists filing monthly)	May 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	May 31, 2007

\* If you file your initial lobby registration after January 1, 2007, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on April 4, 2007, that registrant's first monthly report (due by May 10, 2007) would cover the period beginning January 1, 2007, and ending April 30, 2007.

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**

<b>Friday, August 10, 2007</b>	<b>August monthly activities report</b>  (all lobbyists filing monthly)	July 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	July 31, 2007
<b>Monday, September 10, 2007</b>	<b>September monthly activities report</b>  (all lobbyists filing monthly)	August 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	August 31, 2007
<b>Wednesday, October 10, 2007</b>	<b>October monthly activities report</b>  (all lobbyists filing monthly)	September 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	September 30, 2007
<b>Tuesday, November 13, 2007</b>  <i>Deadline extended because of weekend and holiday.</i>	<b>November monthly activities report</b>  (all lobbyists filing monthly)	October 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	October 31, 2007
<b>Monday, December 10, 2007</b>	<b>December monthly activities report</b>  (all lobbyists filing monthly)	November 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	November 30, 2007
<b>Thursday, January 10, 2008</b>	<b>January monthly activities report</b>  (all lobbyists filing monthly who were registered in 2007)	December 1, 2007, <i>or</i>  January 1, 2007, if first activities report*	December 31, 2007
<b>Thursday, January 10, 2008</b>	<b>Annual activities report</b>  (all lobbyists filing under the modified reporting schedule who were registered in 2007)	January 1, 2007	December 31, 2007

\* If you file your initial lobby registration after January 1, 2007, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on April 4, 2007, that registrant's first monthly report (due by May 10, 2007) would cover the period beginning January 1, 2007, and ending April 30, 2007.

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**
