IMMIGRATION SERVICES: LEGAL ASSISTANCE IN TEXAS

Update: September 13, 2006

WHO MAY LEGALLY PROVIDE IMMIGRATION SERVICES?

With minor exceptions, immigration services may be provided only by:

- 1. licensed attorneys;
- 2. law students under certain supervision;
- 3. certain persons with a pre-existing relationship with the immigrant and who are working for free; and
- 4. accredited representatives of a non-profit religious, charitable, social service, or similar organization established in the United States and recognized as such by the Board of Immigration Appeals (also called the "BIA" see important information about the BIA below).

A notary public or a "notario publico" cannot help you with immigration forms unless they are approved by the federal government and working for an organization that is also approved by the federal government.

LICENSED ATTORNEYS - Attorneys are licensed by the state in which they practice law. In order to verify that an attorney is licensed and is in good standing in the state in which he or she is licensed to practice, contact the State Bar Association in the state in which the attorney is practicing law. In Texas, the contact information is the State Bar of Texas, **www.texasbar.com**.

You can also find out if an attorney is specialized in Immigration and Nationality Law by the Texas Board of Legal Specialization Certifications. A lawyer could be experienced and helpful in providing immigration assistance and not be "board certified." Lawyers who are board certified in immigration law need to specialize in immigration work and pass a special exam before they can advertise that they are "board certified." The Texas Attorney General's Office does not recommend one type of lawyer over another, but simply provides this information so that you can understand what the term "board certified" means.

The **State Bar of Texas Lawyer Referral Information Service** helps find lawyers for persons in counties where there is no local lawyer referral service. Hours of operation are Monday through Friday, 8:00 a.m. to 5:00 p.m.

Here's how it works:

- Call 1-800-252-9690 or 1-877-983-9227. You will be asked in which county you need a lawyer and to briefly state your problem.
- You will be given the name and phone number of an attorney. When you call the attorney
 to schedule a meeting, it is very important that you tell him or her that you were referred
 by the State Bar of Texas.
- Your 30 minutes of legal consultation will cost you \$20. After that initial 30 minutes, it is
 up to you and the attorney to negotiate fees if you decide to authorize the lawyer to take action
 on your legal problem.

AlLA - The American Immigration Lawyers Association (AlLA) is the national association of over 8,000 attorneys and law professors who practice and teach immigration law. Founded in 1946, AlLA is a nonpartisan, nonprofit organization that provides its members with continuing legal education, information, professional services, and expertise through its 35 chapters and over 50 national committees.

AlLA can help find an immigration attorney through Immigration Lawyer Referral Service (ILRS). No more than \$100 will be charged for an initial half-hour consultation. For an attorney referral, call 1-800-954-0254 or e-mail ilrs@aila.org. The e-mail should contain your name, location and what your need is for an immigration lawyer, e.g., asylum, deportation, etc. When you speak to the lawyer, it is very important that you mention that you received his or her referral through AlLA's Immigration Lawyer Referral Service.

BIA RECOGNIZED AGENCIES - The Board of Immigration Appeals (BIA) is the highest tribunal on immigration and nationality matters in the United States. The BIA is responsible for the recognition of organizations and the accreditation of representatives wishing to appear before the Immigration Courts, the Department of Homeland Security and the BIA.

A list of the non-profit organizations recognized by the BIA can be found on its website, www.usdoj.gov/eoir/statspub/raroster.htm, which is updated quarterly. Representatives of those organizations must be designated by such organizations and be accredited by the BIA. Accredited representatives may not provide representation of individuals unless they work under the direction and for the recognized non-profit organization recognized by the BIA.

The BIA's list is organized alphabetically by name of the organization, including the accredited individuals who work for those organizations. If the name of the organization appears, but the name of an individual does not appear under the organization's name, this means either that the organization does not yet have an approved person to provide immigration services or that the individual who was approved no longer works for the organization. The dates correspond to the date the organization and the individual were recognized and accredited by the BIA. For ease of locating organizations in Texas, the following list is arranged alphabetically by city. The following organizations are recognized to provide immigration services as of May 4, 2006:
