## letter from texas attorney general greg abbott

December 8, 2006

Survivors of violent crime never look at the world around them in quite the same way. Many tell us about a new perspective they have on life, because they know how fragile and precious it is. That is a remarkable reminder of the resiliency of the human spirit, because violence often carries with it extraordinary physical, emotional, and financial pain. It is a perspective that teaches us that what is important in life is not only what happens to us, but how we respond to it.

Recently a 98-year-old widow wrote to thank us for the Crime Victims' Compensation program. Her son was murdered, and the program was able to assist with his funeral expenses. She will never look at the world as she did before her son died, but her perspective on life - after nearly a century of living and while staring into the face of the most profound grief - gives her the ability to express her heartfelt gratitude for those who reached out to help her.

Crime victims don't choose the path they walk. In the face of often unspeakable hurt, they are asked to find the courage to rebuild and heal. We are privileged to help them find that perspective. Last year, we received 37,313 applications and awarded more than \$83 million in compensation on behalf of victims and their families. We also distributed nearly \$34 million in grants to nonprofit and public organizations providing emergency shelter, crisis counseling, court accompaniment, and other assistance.

Behind the dollars and the numbers are real people with real issues - and real courage: children who are brave enough to tell; sexual assault survivors who face their accusers; domestic violence victims who break the cycle of violence; victims of drunk drivers who volunteer to help others. They are people determined not to let a senseless act of violence define their lives. They are people who have found the perspective to continue.

We look forward to working with the Legislature, with victims, and with advocates to ensure that the Crime Victim Services Division continues to help the victims of violent crime become survivors.

## crime victims' compensation fund history & highlights

In 1979, the Texas Legislature passed the Crime Victims' Compensation Act, which created the Compensation to Victims of Crime Fund (Fund) and the Crime Victims' Compensation (CVC) Program. The primary purpose of the Fund is to encourage greater victim participation in the apprehension and prosecution of criminals, and to reimburse innocent victims for certain out-of-pocket expenses incurred as a result of the crime.

CVC was initially administered by the Texas Industrial Accident Board, later known as the Workers' Compensation Commission. The Office of the Attorney General (OAG) performed the limited role of investigating claims. In 1991, the entire program and staff were moved to the OAG, and the Crime Victims' Compensation Division was created.

CVC's ability to provide financial assistance to crime victims has always been related to the solvency of the Fund. The majority of the revenue for the Fund comes directly from convicted offenders in the form of court costs and other fees. In early 1993, the financial soundness of the Fund was jeopardized when requests for victim compensation exceeded the amount of funds that had been accrued from court costs and fees. As a result, CVC reduced compensation payments to service providers by 40%. In 1993, the Legislature passed a bill that increased the amount of court costs and fees going into the Fund. Within one year, CVC was financially able to reimburse victim service provider payments at 100%. As a result of the increase in court costs and fees, the Fund balance began to increase, exceeding the amount of payments to victims and resulting in a surplus.

In 1997, the Fund became a constitutionally dedicated account to be used only for the purpose of providing victim-related compensation or assistance. In addition, the Legislature amended the Texas Code of Criminal Procedure to authorize the OAG to use monies appropriated from the Compensation to Victims of Crime Fund for grants and contracts supporting victim-related services or assistance. During this time, the Fund continued to experience exceptional revenue growth. As the balance in the Fund continued to increase, the Legislature expanded compensation benefits offered to crime victims and increased the maximum award amount on claims. As a result, CVC offered benefits for catastrophic injuries, and crime scene

clean-up, as well as relocation expenses for victims of family violence and sexual assault in their residence.

In 2001, the Legislature appropriated funds to the OAG for the purpose of providing grants to a broad range of victim-related service organizations. Victim services such as domestic violence shelters, rape crisis centers, hotlines, victim advocacy, education and assistance with CVC applications were available as a result of these partnerships and grants. The ability to offer grants to victim service providers reflected the intent of the Fund by continuing to expand the types of services and benefits offered to victims of crime. However, beginning with the 2000-2001 biennium, legislative appropriations from the Fund began to exceed revenues, causing concern about whether the Fund would remain solvent.

In January of 2004, Attorney General Abbott convened a diverse group of Texas' leading victim advocates, representing thousands of crime survivors, for their suggestions and recommendations to help protect and ensure the solvency of the Fund. Their objective was to develop recommendations that addressed the needs and concerns of all types of crime victims throughout the state of Texas. In January of 2005, General Abbott submitted recommendations on their behalf to the Legislature.

In 2005, the Legislature acted on these and other recommendations by passing legislation that will increase Fund revenue in years to come. Specifically, changes to the laws governing restitution now emphasize that the Fund is an eligible recipient of court-ordered restitution. A court can order an offender to pay restitution directly to the Fund for any amounts paid from the Fund on behalf of a victim. Another change to the laws governing restitution allows for a one-time fee of \$12 to be assessed on an offender who pays court-ordered restitution in installments. The Fund will receive \$6 and the court that assessed the fee will retain the remaining \$6. Legislation was also passed that requires certain counties and municipalities to implement a court cost collection program to increase the collection rate of outstanding court costs and fees, which will increase Fund revenue.

## crime victims' compensation revenue sources

The Crime Victims' Compensation (CVC) Program is supported through a legislative appropriation from the Compensation to Victims of Crime Fund (the Fund). The passage of the Crime Victims Compensation Act in 1979 reflected the Legislature's intent for the Fund to assist innocent victims of violent crime and to encourage greater public cooperation in the investigation and prosecution of criminals. The Fund represents public policy at its best: revenue for the Fund is collected from offenders through criminal court costs, fees, and fines, while victims of violence are assisted with expenses related to the crime. The Fund receives revenue from the sources outlined below.

#### STATE COURT COSTS

CVC receives 37.6338% of all consolidated court costs submitted to the comptroller by local governmental entities for felony and misdemeanor convictions. Court costs received by type of conviction\*:

Felony Conviction - \$50.05 Misdemeanor Conviction punishable by imprisonment or fine of more than \$500 - \$31.24 Misdemeanor Conviction punishable by imprisonment or fine of \$500 or less - \$15.05

#### FEDERAL VOCA GRANT

The federal Victims of Crime Act (VOCA) allows the collection of fines, fees and forfeitures for federal convictions. Passed in 1984, VOCA has awarded grants to the Texas Crime Victims' Compensation Program since 1986. These grants are made on the basis of a formula that gives each state an amount equal to 60 percent of the state funds paid to victims two years prior.

#### RESTITUTION

Offenders may be ordered to reimburse the Fund for compensation payments made on behalf of those they have victimized. CVC staff provide local prosecutors with information on the amount of money that has been paid so reimbursement to the Fund can be included in restitution orders. Recent changes to the laws governing restitution will now allow for a one-time fee of \$12 to be assessed on an offender who pays restitution in installments. Half of this fee is deposited into the Fund.

A judge may require an offender to pay a one-time fee of up to \$50 for misdemeanors and up to \$100 for felonies to the Fund.

#### PAROLEE SUPERVISION FEE

Offenders on parole for crimes that occurred after September 1, 1993, pay \$8 per month to the Fund. The state's parole officers are to be credited for their efforts to collect these fees from parolees.

#### **DONATIONS**

Jurors are provided information about the Fund and are offered the option of donating their daily reimbursement to the Fund.

### **SUBROGATION**

By statute, the Attorney General must ask that the victim or claimant reimburse the Fund for the amount paid on behalf of the victim, up to the amount of the civil award when a crime victim is awarded money in a civil suit.

## crime victims' compensation program overview

The Crime Victims' Compensation Program (CVC) is administered by the Office of the Attorney General and is dedicated to ensuring that victims of violent crime are provided financial assistance for crime-related expenses that cannot be reimbursed by insurance or other sources.

The Crime Victims' Compensation Program is "the payer of last resort" after primary sources of payment such as health insurance, Medicaid, Medicare, auto insurance, or Texas Worker's Compensation. CVC program staff assist applicants in coordinating the use of all available resources.

#### TO BE ELIGIBLE a person must:

- Be a U.S. resident if the crime occurs in Texas, or a Texas resident who becomes a victim in a state or country without a compensation program;
- Report the crime to a law enforcement agency within a reasonable period of time but not so late as to interfere with or hamper the investigation and prosecution of the crime: and
- File an application for CVC within three years of the date of the crime.

#### TO QUALIFY a person must:

- Be an innocent victim of crime who suffers physical or emotional harm or death;
- Be a dependent of a victim;
- Be an authorized individual acting on behalf of a victim;
- Assume the obligations or voluntarily pay certain expenses related to the crime on behalf of the victim;
- Be an immediate family or household member related by blood or marriage who requires counseling as a result of the crime; or
- Be a peace officer, fire fighter, or individual who has a duty to protect the public and who is injured as a result of violent crime.

#### **BENEFITS:**

Claims may be approved for benefits up to a total of \$50,000 for a crime that occurred on or after September 1, 1997. Individuals who suffer total and permanent disability as a result of the crime may qualify for an additional \$75,000, which may be used for specific and limited expenses such as lost wages, prosthetics, rehabilitation or making a home wheelchair accessible.

The financial assistance may be limited or unavailable depending on laws in effect when the crime occurred and is dependent upon the applicant providing necessary and required documentation.

#### BENEFITS MAY BE AWARDED for:

- Medical, hospital, physical therapy or nursing care
- Psychiatric care or counseling
- One-time relocation assistance for a victim of family violence or a victim of sexual assault who is assaulted in his/her place of residence
- Loss of support
- Loss of wages and travel expense reimbursement for participation in or for attendance at investigative, prosecutorial, or judicial proceedings; to seek medical treatment or counseling; or to attend the funeral of a deceased victim (bereavement leave)
- Funeral and burial expenses
- Care of a child or dependent
- Crime scene clean-up
- Items seized by law enforcement
- Attorney fees

### APPLYING for compensation:

Every law enforcement agency and prosecutor's office in Texas is mandated to provide victims of crime with information about the Crime Victims' Compensation Program. Applications are also available at hospitals and non-profit agencies that work with crime victims.

Applications in English and Spanish can be obtained directly from the Crime Victims' Compensation Program. CVC staff are available to help victims and their families access this program.

## crime victims' compensation activity summary

### 37,414 applications were received in Fiscal Year 2006

29,648 applications were filed by victims of crime

77.02 percent of all reviewed applications were approved

\$5,063 was the average amount awarded per victim application

7,883 sexual assault exam reimbursements were made

\$356 was the average amount awarded per sexual assault exam reimbursement

For example: Claims received in the latter part of August 2006 may not be reviewed or approved until September 2006 (fiscal year 2007) and would not be counted until the next year's report. The same explanation applies to award payments, which in some cases may extend over several years.





## crime victims' compensation benefits

Benefits for crimes occurring before September 1, 1997, have a \$25,000 maximum award. For crimes occurring on or after September 1, 1997, awards on any one claim may not exceed \$50,000. Victims who have suffered a catastrophic injury may be eligible for additional benefits as listed below. Awards may be made in the following categories for necessary expenses related to the crime, up to the appropriate maximum.

MEDICAL expenses related to the crime are paid using established guidelines. Benefits may be paid for hospitals, doctors, ambulance services, prescriptions, dental work, nursing homes, and medical appliances such as wheelchairs and prosthetics.

MENTAL HEALTH CARE in a hospital facility may be available to a victim for a maximum of 30 days at a rate of \$600 per day. Victims and claimants may receive outpatient therapy from a licensed provider up to a maximum of \$3,000. This benefit may require preauthorization.

LOST WAGES may be paid to a victim who is unable to work as a result of physical or mental injuries related to the crime. Lost wages may also be awarded when a victim misses time from work to seek medical treatments for injuries related to the crime or when the victim or claimant take part in the criminal justice process (other than testifying). The award maximum is \$500 per week.

TRAVEL EXPENSES may be reimbursed for costs related to seeking medical treatment or counseling and for costs associated with the victim's or claimant's participation in or attendance at investigative, prosecutorial, judicial, or post adjudication proceedings. Mileage is covered for travel of more than 20 miles one way. The actual costs of commercial transportation, food and lodging are paid for travel of more than 60 miles one way. Additionally, expenses for travel to the funeral or memorial of a victim (who died as a result of criminally injurious conduct committed on or after September 1, 2003) may be paid for certain family or household members.

CHILD/DEPENDENT CARE expenses may be covered if the expense is new and a direct result of the crime. Pre-existing child care costs are not reimbursable. For crimes occurring on or after May 8, 2005, child care benefits for dependent(s) of a surviving victim may be limited to a maximum of 90 days. The award is paid at the actual cost of care, not to exceed \$100 per week, per dependent or minor child in a licensed day care facility or provider.

**FUNERAL AND BURIAL** expenses include reimbursement for professional burial services, flowers, caskets, urns and grave markers. The maximum award on these costs is \$4,500. The reasonable costs for transporting the body to another state or country are eligible costs in addition to the \$4,500 award.

LOSS OF SUPPORT benefits are available to dependents of homicide victims. Payments are based on the victim's salary, and the maximum is \$500 per week. Loss of support is also available to dependents of victims (usually in family violence cases) for 90 days.

CRIME SCENE CLEAN-UP costs must relate to the removal of crime scene elements that may cause further trauma to the victim or family members. The reimbursement is limited to \$750.

**EVIDENCE REPLACEMENT** awards may be made for items that have been seized by law enforcement for use in the investigation or prosecution of a case or items seized and damaged during evidence collection. The maximum award for this expense is \$750.

**RELOCATION** expenses are available as a one-time award of up to \$3,800 (\$2,000 for relocation expenses and up to \$1,800 for rental assistance). This benefit provides victims of family violence and victims of sexual assault (in their residence) with funds to pay for moving expenses, utility deposits, moving vans, and rent.

CATASTROPHIC INJURIES are those that create a total or permanent disability for the victim. An additional award of \$25,000 (for crimes occurring before September 1, 1997), \$50,000 (for crimes occurring September 1, 1997 to August 31, 2001), or \$75,000 (for crimes occurring on or after September 1, 2001) may be used to pay for items that directly assist the victim, such as lost wages, making a home or vehicle accessible, job training and vocational rehabilitation, home health care, or training in the use of special appliances.

BEREAVEMENT LEAVE is available for crimes occurring on or after September 1, 2003, to immediate family or household members of the deceased victim at the time of the crime. The reimbursement is limited to 10 days up to a maximum of \$1,000.

ATTORNEY FEES may be paid for legal services related to the Crime Victims' Compensation process. Attorney fees are paid only if the victim is awarded compensation. Those fees are limited to the lesser of \$300 or 25 percent of awarded benefits. If the claim is appealed, the attorney may be entitled to 25 percent of the amount the attorney assisted the victim or claimant in obtaining.

**EMERGENCY AWARDS** may be requested if a victim or claimant would suffer undue harm or hardship if an award is not expedited. The award limit is \$1,500 and will be deducted from any future awards.







## grants & contracts program overview

In cooperation with the Texas Legislature, the Office of the Attorney General (OAG) provides vital support to victims of crime throughout the state by awarding grants and contracts to hundreds of local and statewide victim assistance programs. Working in partnership with local law enforcement agencies and non-profit organizations, the OAG continues to focus on minimizing the physical and emotional trauma experienced by children and adults who are victims of crime. Through these awards the OAG demonstrates commitment to cultivating an environment where the needs of crime victims are expediently identified and effectively met in communities of every size. The fiscal support provided by the OAG helps to empower communities to develop strong local networks that reflect their respective crime victim population needs.

The Texas Code of Criminal Procedure, Article 56.541, authorizes the OAG to use monies appropriated from the Compensation to Victims of Crime Fund for grants and contracts supporting victim-related services or assistance. The OAG administers the following eight victim assistance grant programs as authorized by the Legislature:

- Other Victim Assistance Grants (OVAG)
- Victim Coordinator and Liaison Grants (VCLG)
- Sexual Assault Prevention and Crisis Services Program (SAPCS)
- Statewide Automated Victim Notification System (Texas VINE)
- Court Appointed Special Advocates (CASA)
- Children's Advocacy Centers (CAC)
- Crime Victim Civil Legal Services (CVCLS)
- Sexual Assault Services Program Grant (TAASA)

In Fiscal Year 2006, the OAG awarded \$33,855,207 to organizations that provide vital victim services in the state of Texas. In addition, the OAG used a total of \$1,908,449 (5.3%) in administrative costs for the oversight and administration of funds appropriated in the Victim Assistance Strategy. These direct and indirect administrative costs include salaries, travel, and operating expenses.

#### **AUDIT & OVERSIGHT ACTIVITIES**

All programs are carefully monitored to ensure the effective use of dollars awarded to the local and statewide programs. To achieve 100% audit and oversight, the OAG conducted one or more of the following procedures for all OVAG, VCLG, and SAPCS grants.

- OAG program staff monitored monthly invoices, financial status reports and quarterly program performance reports.
- OAG program staff conducted 86 on-site monitoring visits.
- Additionally OAG program staff provided technical assistance on a wide range of topics to promote financial and programmatic compliance.



## grants & contracts other victim assistance grants (ovag)

#### **PURPOSE**

The Other Victim Assistance Grants (OVAG) program supports services that address the unmet needs of victims of crime.

#### **GUIDELINES FOR SELECTION**

The OVAG program rules and regulations are set forth in the Texas Administrative Code, Title I, Part 3, Chapter 60. The OAG awards OVAG funds through a competitive application process. Eligible applicants must be a governmental entity or maintain legal status as a 501(c)(3) non-profit organization. To be considered for funding, applicants must demonstrate within their grant proposals an ability and willingness to effectively provide direct victim services. Other vital services for which funding is allowed include:

- · Victim services training
- Public Awareness regarding victim assistance
- · Emergency funds for victims
- · Other support for victim services as determined by the OAG

For grants awarded in FY 2006, applications were carefully evaluated and scored by a team of internal OAG staff. Scoring was based on information and documentation provided by the applicants, including a description of project activities, project objectives and outcomes, and proposed project budgets.

#### **AWARDS**

For FY 2006, the OAG awarded 182 grants totaling \$9,999,660. These grants went to a variety of non-profit organizations and government entities committed to providing crime victim services throughout Texas. Included in these totals are 3 contracts to administer Block Grants:

- Children's Advocacy Centers of Texas, Inc. (23 subrecipients for \$1,141,353)
- Texas CASA, Inc.
   (15 subrecipients for \$668,476)
- Mothers Against Drunk Driving (6 service regions for \$330,000)

#### SUMMARY OF REPORTS AND EFFECTIVENESS

OVAG funded programs served 43,549 victims of crime. These victims received 80,688 crisis interventions, therapy sessions, and follow-up services during FY 2006. Additionally, victims received assistance with applying for Crime Victims' Compensation in 8,994 instances and information about victim rights and available community resources in 62,126 instances.



## grants & contracts victim coordinator & liaison grants (vclg)

#### **PURPOSE**

Victim Coordinator and Liaison Grants (VCLG) support statutorily required Victim Coordinator and Victim Liaison positions for local law enforcement agencies and prosecutor offices. The law enforcement liaisons and prosecutor coordinators funded by these programs provide direct services to victims of crime, assisting them with Crime Victims' Compensation and other statutory rights.

#### **GUIDELINES FOR SELECTION**

The VCLG program rules and regulations are set forth in the Texas Administrative Code, Title I, Part 3, Chapter 60. In FY 2006, the OAG decided whether to fund continuing programs based on an evaluation of their prior performance, including compliance with grant guidelines and the accuracy and timeliness of required financial and programmatic reports. Funds for new programs were awarded through a competitive application process. Scoring was based on information provided by the applicants including a description of proposed project activities, objectives, outcomes, and budget.

#### **AWARDS**

For FY 2006, the OAG awarded 61 VCLG grants totaling \$2,297,599. These grants went to:

- 42 Prosecutor's Offices
- 14 Police Departments
- 5 Sheriff's Offices

#### SUMMARY OF REPORTS & EFFECTIVENESS

VCLG funded programs served 23,352 victims of crime in FY 2006. These victims received assistance with applying for Crime Victims' Compensation in 6,078 instances, and help with completion of victim impact statements in 3,851 instances. Additionally, victims received 17,684 advocacy services and information about victim rights and community resources in 31,819 instances.



## grants & contracts sexual assault prevention & crisis services grants

#### **PURPOSE**

The Sexual Assault Prevention and Crisis Services (SAPCS)
Program awards grants to support local and statewide programs that are addressing the problem of sexual assault through direct services, training, and education.

#### **GUIDELINES FOR SELECTION**

The SAPCS program rules and regulations are set forth in the Texas Administrative Code, Title I, Part 3, Chapter 62. Funds to local sexual assault programs are awarded via contract with the OAG. To be eligible to receive SAPCS funding, applicants must be a 501(c)(3) non-profit organization or governmental entity that offers the required basic services for at least nine months prior to receiving an award. These basic services include:

- 24-hour hotline
- Crisis intervention
- Accompaniment to medical facilities, law enforcement and prosecutor offices
- Public education
- Professional training
- Volunteer training

In FY 2006 the amount a sexual assault program was awarded was determined through a formula that included a base amount of funding and additional funds allocated by percent of basic services provided in FY 2005.

#### **AWARDS**

In FY 2006, the OAG awarded 80 contracts totaling \$8,465,346:

- Seventy-six contracts were awarded to local sexual assault programs across the state to provide sexual assault prevention services in addition to the victim services listed above.
- One contract was awarded to the Texas
   Association Against Sexual Assault (TAASA) to provide training and technical assistance to local sexual assault programs and support a statewide public awareness campaign.
- Three contracts were awarded for sexual assault nurse examiner training services.

#### SUMMARY OF REPORTS & EFFECTIVENESS

In FY 2006, local sexual assault centers reported providing services to 37,327 survivors from 238 counties. Of these survivors:

- 14.15% were male, 85.59% were female; and for .26% the gender was unknown.
- 59.14% were adults; 28.19% were children; and for 12.67% the age was unknown.

These programs also reported presenting 25,792 education and training sessions to 1,004,625 community members, students, and professionals.



## grants & contracts sexual assault nurse examiner (SANE) program

#### **PURPOSE**

A component of the Sexual Assault Prevention and Crisis Services Program, the Sexual Assault Nurse Examiner (SANE) Program trains and certifies registered nurses to perform sexual assault medical forensic examinations when a patient indicates that he/she has been sexually assaulted. SANEs offer services to sexual assault patients regardless of age or gender. The Sexual Assault Nurse Examiners provide:

- compassionate and sensitive sexual assault medical forensic examinations
- timely collection of evidence
- · consistent care
- referral for follow-up care and counseling

#### COMMUNITY DEVELOPMENT PROCESS

A strong, coordinated community response to sexual assault supports the victim, the community, and ultimately the state as a whole. The OAG met with 12 communities in FY 2006 to assist with the development and initiation of Sexual Assault Response Teams (SART). The OAG provides ongoing technical assistance and support to SARTs and encourages cooperative working agreements and monthly meetings. The multidisciplinary groups collaborate to support SANE programs and enhance prosecution. Group members include prosecutors, law enforcement, medical professionals, direct service providers, and advocacy groups. Members of the SART work together to assess community needs and to develop protocols to address the medical, forensic, and legal components of services for sexual assault victims. To date, the OAG has worked with 56 communities to form SARTs.

#### SANE CERTIFICATION PROCESS

In FY 2006, the OAG provided 20 trainings for 203 nurses agreeing to conduct sexual assault medical forensic examinations in 35 hospitals. To be eligible for SANE training, a registered nurse must be in good standing with the Texas Board of Nurse Examiners for a minimum of two years prior to course participation. SANE training includes classroom, clinical, and courtroom components. The classroom component covers information on current laws specific to sexual assault and evidence collection, symptomology of survivors, needs of special populations, and witness preparation. Upon completion of the clinical and courtroom requirements, a nurse may apply to the OAG for certification as a Certified Pediatric SANE, a Certified Adult SANE or both. Sexual Assault Nurse Examiners are originally certified for a period of two years. A SANE may apply for recertification at the end of this period. SANEs are required to provide documentation of continuing education and examinations.



## statewide automated victim notification system (Texas VINE)

Texas VINE covers 93.2% of the state's population and 96.2% of the reported violent crime in Texas.

#### **PURPOSE**

The Statewide Automated Victim Notification System, also known as Texas VINE (Victim Information and Notification Everyday), establishes and maintains a reliable and efficient system for notifying victims of crime about the status of offenders. The right to be notified of court proceedings upon request is a basic right afforded to victims by the Texas Constitution. The Texas Legislature allocated resources to the OAG to facilitate the implementation of a statewide automated victim notification system. In response, the OAG, through a competitive process, certified Appriss, Inc. to work directly with Texas counties who seek to participate in the statewide program, Texas VINE.

#### Texas VINE

Texas VINE provides victims and concerned members of the community with up-to-date information about offenders' county jail custody and court status, 24 hours a day, seven days a week, 365 days a year via a single statewide toll-free telephone number (1-877-TX4-VINE).

Information is transferred from participating county databases to the national VINE Communications Center every fifteen minutes. Users register with the Texas VINE service by calling 1-877-TX4-VINE/1-877-894-8463 or by logging on to www.VINElink.com. Registered users are then contacted by phone or email if there is a change in status. Users may also check on status at any time by phone or by linking with the website. Trained operators are available at all times. In FY 2006, Texas VINE received 1,146,048 incoming calls, made 63,265 confirmed notification calls, and had 64,811 new victims register for notification.

#### **AWARDS**

The program is funded through a legislative appropriation. In FY 2006, the OAG awarded 135 contracts totaling \$3,090,588. The OAG issues original and annual maintenance contracts to each participating county for the purpose of funding the program. At the end of FY 2006, 143 counties and the Texas Department of Criminal Justice were participating in this voluntary program.

#### **CONTRACT MANAGEMENT**

To assure that the certified vendor and the county are functioning within the requirements of the program, the OAG regularly assesses them to verify compliance with standards and protocols. Oversight activities included desk reviews of documentation and reports as well as on-site visits to provide technical assistance and/or audit fiscal and programmatic activity.

#### **PURPOSE**

The purpose of the Court Appointed Special Advocates (CASA) grant is to develop and support local CASA programs throughout Texas. CASA programs recruit, train, and provide courtappointed volunteers to advocate on behalf of the best interests of abused and neglected children involved in the legal and welfare systems.

#### **GUIDELINES FOR SELECTION**

The Office of the Attorney General is legislatively directed to contract with a statewide organization with expertise in the dynamics of child abuse and neglect as well as experience in operating volunteer advocate programs that provide training, technical assistance and evaluation services. The designated funds are awarded to Texas CASA, Inc., the statewide organization, which then contracts with local programs to provide direct victim services. The Texas Family Code, Chapter 264, Subchapter G, specifies the eligibility criteria for a local CASA program to receive funds from Texas CASA, Inc. The local programs applying for funds must be 501(c)(3) non-profit organizations operating an advocate program that:

- Uses volunteers appointed by the court to provide for the needs of abused or neglected children;
- Provides services that encourage permanent placements for abused and neglected children;
- Has provided court-appointed advocacy services for at least two years;
- Provides court-appointed advocacy services to at least ten (10) children each month;
- Has demonstrated local judicial support; and
- Has demonstrated fiscal support from the community.

#### **AWARDS**

For FY 2006, the OAG awarded one contract to Texas CASA, Inc., for \$3,158,011\*. Texas CASA, Inc. then awarded 60 contracts totaling \$2,640,000 to local CASA programs. The balance of the award was utilized by Texas CASA, Inc., for administrative costs to oversee and support the local CASA programs.

#### SUMMARY OF REPORTS AND EFFECTIVENESS

For FY 2006, local CASA programs provided services to 20,233 children in 199 counties. Three new local CASA programs were developed to cover additional counties. As a result, five new counties were served. These services were provided by 4,707 local CASA volunteers and CASA staff. Of the children served, 10,276 were male and 9,957 were female.

- 17,964 reports were provided to the courts on the progress and well-being of children in state care.
- 1,593 volunteers were trained at local CASA programs to provide advocacy services to children in state care.
- 5,194 people received in-service training at local programs.

#### **AUDIT & OVERSIGHT ACTIVITIES**

To ensure accountability for these funds, the following audit and oversight activities were conducted:

- All programs submitting Requests for Reimbursement were reviewed monthly and a desk review was performed with each program during the first month of the grant cycle.
- Texas CASA, Inc., conducted nine on-site quality assurance reviews in FY 2006. These reviews included assessments of the volunteer program, service provision and organizational stability of the local programs.
- OAG staff conducted an on-site monitoring visit of Texas CASA, Inc.



## grants & contracts sexual assault services program grant

#### **PURPOSE**

The purpose of the Sexual Assault Services Program Grant is to provide program development, technical assistance, and training to local sexual assault programs. The grant also provides statewide training for local programs, law enforcement agencies and other victim services groups.

## **GUIDELINES FOR SELECTION**

The Office of the Attorney General is legislatively directed to contract with a statewide organization with expertise in understanding the dynamics of sexual assault, developing informational materials, and providing training for sexual assault programs and community professional groups. The designated funds are awarded to the Texas Association Against Sexual Assault (TAASA), the membership organization supporting sexual assault crisis intervention and prevention programs throughout the state.

### **AWARDS**

For FY 2006, one grant totaling \$375,000 was awarded to TAASA for the Sexual Assault Services Program activities.

### SUMMARY OF REPORTS AND EFFECTIVENESS

For FY 2006, TAASA provided training and educational materials to the 76 sexual assault programs funded by the OAG and community professionals working with sexual assault survivors. Training for law enforcement was provided to 173 participants representing different law enforcement groups. TAASA distributed 15,589 fact sheets on a variety of topics concerning issues sexual assault programs must address. Other activities and educational materials provided by TAASA include the following.

- Updated and distributed 116,732 topical brochures to sexual assault programs.
- Provided 202 training manuals on community collaboration and communication to sexual assault programs.
- Provided training on working with the media to 137 sexual assault program staff.
- Provided training to 200 participants attending six regional trainings.
- Worked with ten sexual assault programs on media relations and improving public awareness.
- Provided technical assistance to six sexual assault programs on various programmatic issues.
- Provided cultural competency training certificates to 30 advocates.

#### **AUDIT AND OVERSIGHT ACTIVITIES**

To ensure accountability for funds awarded to TAASA, the following audit and oversight activities were utilized.

- OAG program staff monitored monthly invoices, financial status and program performance reports.
- OAG program staff approved the budget and any budget amendments, and reviewed training and educational materials prepared by TAASA.
- OAG program staff conducted an on-site monitoring visit with TAASA in FY 2006.



## grants & contracts children's advocacy centers

#### **PURPOSE**

The purpose of the Children's Advocacy Centers (CAC) grant program is to develop and support local child advocacy centers that offer a coordinated, multidisciplinary response to cases of suspected child physical and sexual abuse.

### **GUIDELINES FOR SELECTION**

The Office of the Attorney General (OAG) is legislatively directed to contract with a statewide organization with expertise in the establishment and operation of children's advocacy center programs. The designated funds are awarded to Children's Advocacy Centers of Texas, Inc. (CACTX), a statewide membership association that then contracts with local CAC programs to provide direct services. Texas Family Code, Chapter 264, Subchapter E, directs CACTX to contract with eligible centers to enhance services of the local CAC programs. The eligibility requirements for a local CAC program to receive funds from CACTX include:

- A signed memorandum of understanding with the local agencies that investigate or prosecute child abuse cases or deliver services to child abuse victims;
- A multidisciplinary team that holds regularly scheduled case reviews:
- · A method of statistical information gathering;
- An in-house volunteer program; and
- Other rules pertaining to the management of contracts.

#### **AWARDS**

For Fiscal Year 2006, the OAG awarded one contract to Children's Advocacy Centers of Texas, Inc. for \$3,999,003. CACTX then awarded 60 contracts totaling \$3,459,124 to 60 local CAC programs. The balance of the award was utilized by CACTX for administrative costs to oversee and support the local CAC programs.

## SUMMARY OF REPORTS AND EFFECTIVENESS

For FY 2006, local CAC programs provided full services in 146 counties and limited services to an additional 86 counties, 38 other states, and 4 other countries. Local CAC programs provided services to 30,103 children, an increase of 6.62% from last year. Of these, 33.26% were male and 66.74% were female.

- 27,718 forensic interviews were conducted.
- 24,999 child abuse cases were reviewed by multidisciplinary teams.
- 15,213 mental health services were provided for alleged child abuse victims and their families.

#### **AUDIT AND OVERSIGHT ACTIVITIES**

To ensure accountability for these funds, the following audit and oversight activities were utilized.

- OAG program staff reviewed and approved the budget and any budget amendments, and reviewed and analyzed the performance reports submitted by CACTX. These reports encompass all of the local programs funded through this contract.
- OAG program staff conducted an on-site monitoring visit with CACTX in FY 2006.
- CACTX conducted 18 on-site quality assurance reviews and 6 desktop quality assurance reviews in FY 2006.
- CACTX reviewed the statistical reports submitted by local programs every quarter and closely reviewed and approved requests for reimbursements from the local programs.



## grants & contracts crime victim civil legal services

#### **PURPOSE**

The Crime Victim Civil Legal Services grants were authorized by the Legislature to increase the availability of free and affordable civil legal services for victims of crime, such as protective orders, disability benefits, and other legal assistance.

#### GUIDELINES FOR SELECTION

The Office of the Attorney General entered into an interagency contract with the Supreme Court of Texas to support the Crime Victim Civil Legal Services grants. The Court contracts with the Texas Equal Access to Justice Foundation (TEAJF) to handle the administrative management of these funds. The requirements for selecting recipient programs are set forth in the Order of The Court establishing TEAJF as the administrator of these funds. To be eligible to apply for these funds, a program must:

- Have 501(c)(3) non-profit organization status;
- Provide victim-related civil legal services to victims, immediate family members of victims or claimants;
- Provide services based on a person's meeting certain income eligibility requirements;
- Maintain open records;
- Conduct open meetings; and
- Comply with other policies adopted by the Court and TEAJF.

TEAJF awards these funds to eligible local programs through a competitive grant application process. TEAJF staff carefully evaluates applicants on their history with TEAJF, including compliance and on-site evaluations, and makes program selection recommendations to the Board of Directors. The Board reviews these recommendations and considers such factors as ability to provide proposed services, underserved populations or areas of the state, and the potential for duplication of services. New applicants make oral presentations to the TEAJF Board of Directors on the organization and the services they propose to provide.

#### **AWARDS**

For FY 2006, the OAG awarded one contract to the Supreme Court of Texas for \$2,500,000. The Texas Equal Access to Justice Foundation, which administers this program for the Court, then awarded 23 grants totaling \$2,412,500 to local crime victim civil legal service programs in Texas. The balance of the award was utilized by TEAJF for administrative costs to oversee and support the local civil legal service programs. These programs include 4 grants that provide services statewide and 19 grants that provide local services.

#### SUMMARY OF REPORTS & EFFECTIVENESS

For FY 2006, local and statewide programs served 24,929 victims of crime in 204 counties. These funds have continued to cultivate a collaborative environment for the growing network of Legal Aid providers and the victim service agencies. Programs also address the growing problem of human trafficking and the extremely diverse services necessary to assist these victims.

### **AUDIT & OVERSIGHT ACTIVITIES**

To ensure accountability for these funds, the following audit and oversight activities were utilized.

- OAG program staff reviewed financial and programmatic reports submitted on a quarterly basis by the Supreme Court of Texas. These reports encompass the financial expenditures and performance of all the local programs funded through this contract.
- Additionally, TEAJF staff conducted one or more
   of the following for all grantees: on-site program
   monitoring; review of quarterly fiscal and programmatic
   productivity reports; review of annual audit; and/or
   review of annual report of services and self assessment.
