# Breast and Cervical Cancer Control Screening

#### Purpose

Screens for and identifies breast and cervical cancers in an effort to reduce breast and cervical cancer mortality.

#### Eligibility

Must have income at or below 200% federal poverty level with no other pay source. Must be age 18-64 for Cervical Cancer Screening. Must be woman age 50-64 for breast cancer screening.

# Case Management for Children and Pregnant Women (CPW)

#### Purpose

Assists with access to medical, social, educational, and other services for women with high-risk pregnancy and children below age 21 with a health condition or risk.

#### Eligibility

Must be Medicaid eligible woman with high-risk pregnancy or Medicaid eligible child age 0-20 with a health condition or risk or children and pregnant women meeting the requirements as defined in Title V (including at or below 185% federal poverty level). (Medicaid eligibility is determined at HHSC.)

# Children with Special Health Care Needs - Comprehensive Medical, Support and Enabling Services

# Purpose

Provides such health care benefits as medical services, family support services, diagnosis and evaluation services, case management, transportation related services, and insurance premium payment assistance services. Services are provided through a network of enrolled providers and through community-based contractors. Note: In the event that a waiting list for health care benefits exists, limitations on diagnosis and evaluation services and family support services are required by program rule. A waiting list was initiated in October 2001.

# Eligibility

Must have income at or below 200% federal poverty level with spend-down allowance, resident of Texas and younger than 21 years of age with a chronic physical or developmental condition OR person of any age with cystic fibrosis.

# **Epilepsy Comprehensive Outpatient Services**

# Purpose

Provides comprehensive epilepsy outpatient services including diagnosis, treatment, case management, education and support services.

Must be uninsured or underinsured with income below 200% federal poverty level and epilepsy or seizure-like symptoms.

# Family Planning

Division of Family and Community Health Services

## Purpose

Provides comprehensive family planning services including education and outreach, and referral (Titles V, XX, XIX), and infrastructure support (Title X).

## Eligibility

Meet the requirements as defined in Title V and at or below 185% federal poverty level (FPL); meet the requirements as defined in Title X and Title XX and at or below 250% FPL; meet the requirements as defined in Title XX and at or below 150% FPL; meet the requirements as defined in Title XX and a Texas resident; meet the requirements as defined in Title XIX: meet Medicaid eligibility (income at or below 17% FPL) or 60 days postpartum at or below 185% FPL.

Meet the requirements as defined in Title V (below 185% federal poverty level) or Medicaid eligible person 0-21 years old; parent of any age; pregnant woman (Medicaid eligibility is determined at HHSC.)

# Hemophilia Assistance

#### Purpose

Provides financial assistance to adults with hemophilia for the reimbursement of blood factor products.

Must be diagnosed with hemophilia, 21 years of age or older, Texas resident, income at or below 200% of federal poverty level, and not eligible for Medicaid or Medicare.

# Indigent Health Care

Division of Family and Community Health Services

## Purpose

Provides the following basic health care services: immunizations, medical screenings, annual physical examinations, inpatient and outpatient hospital services, rural health clinics, laboratory and X-ray, family planning, physician, skilled nursing facility, and payment for three prescription drugs a month. Counties may choose to provide optional health care services such as: ambulatory surgical center, diabetic and colostomy medical supplies and equipment, physician assistants, nurse practitioners, dental care, vision care, and psychological counseling. All services must be medically necessary.

#### Eligibility

Must not be categorically eligible for Medicaid, with income ranges from at or below 21% federal poverty level up to 50% federal poverty level. Household resources may not exceed \$2000 or \$3000 for households where an aged or disabled person lives in the home.

# Kidney Health Care

#### Purpose

Provides financial assistance for drugs, medical and travel services to or on behalf of clients with end stage renal disease or who have had a kidney transplant.

#### Eligibility

Must have adjusted gross income of less than \$60,000/yr; have diagnosis of end stage renal disease (ESRD); resident of Texas; meet the Medicare criteria for end stage renal disease; be receiving regular course of chronic dialysis treatments or have had a kidney transplant; submit application through processing facility; may not be eligible for full Medicaid benefits.

# Maternal and Child Health Services (Title V)

Division of Family and Community Health Services

#### Purpose

Provides prenatal care, child health, dysphasia, dental for children, population-based activities, enabling services such as case management and education.

Must be Texas resident at or below 185% federal poverty level and not eligible for other programs that provide the same services. Must be a child ages 0-21 or woman of child-bearing age.

# Newborn Hearing Screening

#### Purpose

The Texas Early Hearing Detection and Intervention (TEHDI) program is the state's newborn hearing screening program. Around 200 birth facilities are screening newborns for hearing loss before the babies go home from the birth visit. Early detection of hearing loss allows babies to receive early intervention services and develop the neural pathways in the brain that are related to sound and hearing.

Provides screening of all newborns for five disorders; provides follow-up on all abnormal results to ensure the primary care provider knows the result of the screen and that appropriate repeat screening, confirmatory testing, referral to specialist, and initial treatment are provided.

Must be pregnant or postpartum woman or a child under age 5, have income at or below 185% federal poverty level, reside in Texas, and have at least one nutrition risk condition (i.e., medical or dietary-based condition).

# Mental Health Community-Based Services to Adults

Division of Mental Health and Substance Abuse Services

# Purpose

Assists consumers in functioning in the community through provision of the following specific services: 1) 24-hour emergency screening and rapid crisis stabilization services; 2) communitybased crisis residential services or hospitalization; 3) community-based assessments, including the development of inter-disciplinary treatment plans and diagnosis and evaluation services; 4) family support services, including respite care; 5) case management services; 6) medication-related services, including medication clinics, laboratory monitoring, medication education, mental health maintenance education, and the provision of medication; and 7) psychosocial rehabilitation programs, including social support activities, independent living skills, and vocational training. A case manager is assigned for each person discharged from a department facility who is in need of care.

#### Eligibility

Adults who have severe and persistent mental illnesses such as schizophrenia, major depression, bipolar disorder, or other severely disabling mental disorders which require crisis resolution or ongoing and long-term support and treatment.

# Mental Health Community-Based Services to Children

Division of Mental Health and Substance Abuse Services

## Purpose

Assists consumers in functioning in the community through provision of the following specific services: 1) 24-hour emergency screening and rapid crisis stabilization services; 2) community-based crisis residential services or hospitalization; 3) community-based assessments, including the development of inter-disciplinary treatment plans and diagnosis and evaluation services; 4) family support services, including respite care; 5) case management services; 6) medication-related services, including medication clinics, laboratory monitoring, medication education, mental health maintenance education, and the provision of medication; and 7) psychosocial rehabilitation programs, including social support activities, independent living skills, and vocational training. A case manager is assigned for each person discharged from a department facility who is in need of care.

Children ages 3 through 17 with a diagnosis of mental illness who exhibit serious emotional, behavioral, or mental disorders and who: 1) have a serious functional impairment or 2) are at risk of disruption of a preferred living or child care environment due to psychiatric symptoms or 3) are enrolled in a school system's special education program because of a serious emotional disturbance.

# NORTHSTAR — Mental Health, Substance Abuse and COPSD Community-Based Services to Children

#### Purpose

Provides coordinated mental health, substance abuse, and COPSD (co-occurring psychiatric and substance use disorders) community-based services to adults and children provided in the service area by a network of providers, with care managed by a contracted Behavioral Health Organization.

# Eligibility

Medicaid recipients: Most TANF and SSI recipients who reside in Collin, Dallas, Ellis, Hunt, Kaufman, Navarro and Rockwall counties (service area) are automatically enrolled because of Medicaid status. Non-Medicaid adults who reside in service area must have countable incomes (gross income less allowable expenses) less than or equal to 200% federal poverty level, must meet clinical eligibility criteria, and cannot have other insurance for the service sought.
