## NOTICE TO POLICYHOLDERS, AGENTS AND STATE INSURANCE COMMISSIONERS

On December \_\_\_\_\_, 2002, petitions for reorganization under chapter 11 of the Bankruptcy Code were filed in the United States Bankruptcy Court in Chicago, Illinois by Conseco, Inc. ("Conseco, Inc."), CIHC, Incorporated, and certain of their finance company subsidiaries. The companies in bankruptcy reorganization are NOT insurance companies. The ONLY companies in bankruptcy reorganization are: Conseco, Inc., CIHC, Incorporated, CTIHC, Inc., Partners Health Group, Inc., Conseco Finance Corp. and Conseco Finance Servicing Corp. Conseco, Inc. is also the direct and indirect parent company to thirteen insurance companies (the "Insurance Companies"). NONE of the Insurance Companies are in bankruptcy. (These thirteen Insurance Companies are listed at the bottom of this Notice).

These chapter 11 filings do not affect the continued operations of the Insurance Companies. The Insurance Companies will continue their businesses as usual. Moreover, the Insurance Companies continue to be subject to the exclusive jurisdiction of the state insurance regulators who are charged with protecting the interests of policy holders and claimants in all states and territories.

For several months, state insurance regulators have closely monitored and will continue to monitor both the financial condition of the Insurance Companies and the development of Conseco, Inc.'s proposed plan of reorganization. Conseco, Inc. has been working closely with these state insurance regulators, and the Insurance Companies meet the solvency standards of the states. Conseco, Inc. and its subsidiaries have been and will continue to fully cooperate with state insurance regulators to protect the interests of policyholders and claimants of the Insurance Companies.

This Notice has been approved by the United States Bankruptcy Court in the Conseco, Inc. bankruptcy proceeding, by order dated December \_\_\_,2002.
