NOTICE ABOUT CERTAIN INFORMATION LAWS AND PRACTICES

With few exceptions, you are entitled to be informed about the information that the Texas Department of Insurance (TDI) collects about you. Under sections 552.021 and 552.023 of the Texas Government Code, you have a right to review or receive copies of information about yourself, including private information. However, TDI may withhold information for reasons other than to protect your right to privacy. Under section 559.004 of the Texas Government Code, you are entitled to request that TDI correct information that TDI has about you that is incorrect. ## TEXAS DEPARTMENT OF INSURANCE - STATE FIRE MARSHAL'S OFFICE RENEWAL CHECKLIST

To renew a license issued to an individual by the State Fire Marshal's Office:

- · the licensee must be an employee or agent of a currently registered firm (except for fire alarm licensees), and
- a complete renewal application must be submitted.

A renewal application is considered complete only if the following items are submitted with the application or are on file in the Licensing Administration section of the State Fire Marshal's Office. A LATE FEE will be due if a renewal application with appropriate fee is not postmarked by the expiration date OR if a renewal application is not deemed complete, according to both statute and rules, before the expiration of the license or within the 30-day notice period.
