RENEWAL CHECKLIST

To renew a license issued to an individual by the State Fire Marshal's Office, a complete renewal application must be submitted.

A renewal application is considered complete only if the following items are submitted with the application or are on file in the Licensing Administration section of the State Fire Marshal's Office. A **LATE FEE** will be due if a renewal application with appropriate fee is not postmarked by the expiration date OR if a renewal application is not deemed complete, according to both statute and rules, before the expiration of the license.
