	The two issues we've seen lately are that we are not receiving the Spanish version in a timely fashion. After the network has been certified, we don't actually require the Spanish version until we have approved the English version. We are seeing some definite lag time between those two events. Before we approve the network we do need the Spanish version of Exhibit 18.	
	The second issue I wanted to speak about today is Exhibit 18 section 28 TAC §10.60(g). The requirement is a statement that except for emergencies, networks must arrange for services including referrals to specialists to be accessible to an employee Services must be arranged on a timely basis on request and within the time appropriate to the circumstances and condition of the injured employee but not later than 21 days after the date of the request. We are seeing two issues when the applicants are attempting to

	comply with that requirement The first, is that it is not only referrals to specialist that must occur within 15 days but it is all care. The network must arrange for services including referrals to specialist. It is not just referrals to specialists: all care must be received within 21 days.	
	The other issue that we've seen a couple of times in Exhibit 18 applications is an attempt to re-word the statement "but not later than 21 days" to say something along the lines of "the last day of the third week of the request" .This is not sufficient to me based on the requirement. It is statutory that it has to be in 21 days and obviously if you look at that, you can see where the last day of the third week after the request is not always within 21 days.	
	If there any questions on Exhibit 18 I'll be glad to answer those now.

	I have two subjects, Network Modifications which we have received very many of, thank you very much everyone. We are pleased to say that they are getting better and better every time. My goal

	for the perfect modification is almost true. As you all know, we'll continue to receive modifications, the required exhibits for the modifications are Exhibits 9, 11, 13 and 18. There have been times when we have received exhibits 10 or 3 and unless you are sending those exhibits because something has changed since certification, there is no need to re-send those for a modification. For example if exhibit 3 changed for some reason then send it as well. If no changed has occurred please leave it out of the service area modification application. Exhibits 9 and 11 require maps, narrative, provider list, and access plans. More than likely, after we receive the modification we will be requiring copies of contracts for the new network. There are several tips that we have placed in the minutes for modifications and I would encourage you to look at those. Review those tips before you send in a medication request. Marty will talk a little bit about Exhibit 18 unless there is something you want to add now.	
	Marty speaking: If for some reason you want to change the sentence in Exhibit 18, you don't like the way it states something or you think it can be stated differently, please send us a red lined version and an attestation that nothing else has changed in that document. This helps because we don't have to review the entire document and delay the approval process. If we receive your Exhibit 18 without the attestation and without it being red lined, then we have to review the entire

	document again. This will obviously slow down the approval process. If you are making minor changes or any change, just let us know by red lining and attesting that nothing else has changed.	
	Q: If you file a modification and you include your service area, would it be only the new parts of the service area or do you basically send in the whole service area as if it were modified? In other words, the original certified area including the new modification?	
	A: Yes and No. First, you must send a map of the counties or service area that has been certified and a map of the proposed service area. We would like to see three maps if possible, a map of just currently certified counties, a map of the proposed and another map of both of those service areas together in different colors. One color for certified and another color for the proposed. This way we can see the entire service area as one in the state of Texas. This is helpful because for provider access for instance, if any of the counties that are proposed for the modification or the contiguous or close to certified areas, we can tell whether accessibility was dependent on those certified counties.	
	Marty speaking: I just wanted to mention that on

	Exhibit 18 we would only be interested in the one map of the final proposed service area. It would include any additional counties and/or service areas, etc. We don't need to see the three maps in Exhibit 18, only the final map of the proposed service area.	
	The other issue I have with Exhibit 18 is to be aware that we review these simultaneously. Exhibits 18 are reviewed along with Olga's exhibits 10 & 11 so I may sign off on your Exhibit 18 but that's all pending on Olga's area approving the service area. For instance, if one county in the proposed area does not meet the requirements then you'll have to go back and modify Exhibit 18 also to exclude that service area or county, whatever it may be. This would all be sent in a deficiency letter.	
	Olga speaking: On 10/26/2006 we had a conference call which included the tips for applicants for network modifications. I would like for you all to see that. I need to reiterate that on occasion we receive the maps and the provider lists that intermingle the certified maps and the proposed and although that is helpful to some degree, in the long run and if you want to send that, that is fine but for purposes for us to review the proposed, please do not intermingle both.

	Everyone should be aware of the IRO transition taking place on Jan. 15, 2007; do we need to briefly discuss the process?	
	A: Yes, please.	
	On Jan. 15, 2007 we will be turning the switch. Currently, and through this weekend, the HWCN Division in TDI at Hobby, has been doing IRO request for our health care plans as well as Worker's Comp Networks. On the 15 th we will take over the responsibility of the IRO assignment for all of the Worker's Comp plans. (Networks and Non-Networks). The process is a little different; they will no longer be going to the Medical Dispute Resolution. That entity at DWC has changed it's name to Medical Fee Dispute Resolution (MFDR). They will only be doing fee disputes, not anything that has to do with medical necessity. If something is denied for medical necessity then it will come to us. We have a request form and have changed the terminology. People are used to the terminology medical necessity denials for DWC and we are changing that terminology to a request for review by an Independent Review Organization. We have the process and the form that needs to be filled out to request an IRO. As of Monday, you will not be using the DWC-60 form. The new form is called LHL009 and it is on our web page in English and Spanish. The instructions for completing the form are on the page. The requestor can fill out the form. The requestor can be the injured employee, the enrollee or the health care provider. Upon completion, submit the form to the carrier or the URA. We have a new online request form that we've been using since December. To do an IRO request, we are no longer encouraging people to mail or fax the forms to us. We would really like for everyone to use the online request form. All that information is on the web page, http://www.tdi.state.tx.us/company/iro_requests.ht ml . We will be doing a presentation on the new process and we'll be putting that documentation on the web page as well.
