Sec. 1001.021. STATE HEALTH SERVICES COUNCIL.

(b) The council is composed of nine members of the public appointed by the governor with the advice and consent of the senate. To be eligible for appointment to the council, a person must have demonstrated an interest in and knowledge of problems and available services related to public health, mental health, or substance abuse.

The council shall study and make recommendations to the (c) commissioner and the commissioner regarding executive the management and operation of the department, including policies and rules governing the delivery of services to persons who are served by the department and the rights and duties of persons who are served or regulated by the department. (d) Chapter 551, Government Code, applies to the council.

Chapter 2110, Government Code, does not apply to the (e) council.

A majority of the members of the council constitute a (f) quorum for the transaction of business.

Appointments to the council shall be made so that each (b) geographic area of the state is represented on the council. Notwithstanding Subsection (a), appointments to the council must reflect the ethnic diversity of this state.

(b) The members of the council shall elect any other necessary officers. (c) The council shall meet quarterly and at other times at the call of the presiding officer. The commission shall make the information available the public and appropriate to state governmental entities. (b)

methods by which consumers and service recipients are notified of the name, mailing address, and telephone number of the department for directing complaints to the department.

Subject to rules adopted by the executive commissioner, (a) the commissioner or the commissioner's designee shall prepare and maintain a written policy statement that implements a program of equal employment opportunity to ensure that all personnel decisions are made without regard to race, color, disability, sex, religion, age, or national origin.

Unless the following are included in a policy statement (b) adopted by the executive commissioner that is applicable to the department, the policy statement must include:

personnel policies, including policies relating (1)to recruitment, evaluation, selection, training, and promotion of personnel, that show the intent of the department to avoid the unlawful employment practices described by Chapter 21, Labor Code; and

(2) an analysis of the extent to which the composition of the department's personnel is in accordance with state and federal law and a description of reasonable methods to achieve compliance with state and federal law.

The policy statement must be: (1)

updated annually;

(2) reviewed by the state Commission on Human Rights for compliance with Subsection (b)(1); and

(3) filed with the governor's office.

SUBCHAPTER D. POWERS AND DUTIES OF DEPARTMENT

Sec. 1001.071. GENERAL POWERS AND DUTIES OF DEPARTMENT RELATED TO HEALTH CARE.

Text of section effective on date the commissioner of state health services is appointed. See Historical and Statutory Notes, post. The department is responsible for administering human

services programs regarding the public health, including:

(1) implementing the state's public health care delivery programs under the authority of the department;

(2) administering state health facilities, hospitals, and health care systems;

(3) developing and providing health care services, as directed by law;

providing for the prevention and control of (4) communicable diseases;

(5) providing public education on health-related matters, as directed by law;

(6) compiling and reporting health-related information, as directed by law;

(7) acting as the lead agency for implementation of state policies regarding the human immunodeficiency virus and acquired immunodeficiency syndrome and administering programs related to the human immunodeficiency virus and acquired immunodeficiency syndrome;

(8) investigating the causes of injuries and methods of prevention;

provide (9) administering а grant program to appropriated money to counties, municipalities, public health districts, and other political subdivisions for their use to provide or pay for essential public health services;

 $(\bar{1}0)$ administering registration of the vital statistics;

(11) licensing, inspecting, and enforcing regulations regarding health facilities, other than long-term care facilities regulated by the Department of Aging and Disability Services;

(12) implementing established standards and procedures for the management and control of sanitation and for health protection measures;

(13) enforcing regulations regarding radioactive materials;

enforcing regulations regarding food, bottled (14)and vended drinking water, drugs, cosmetics, and health devices;

(15) enforcing regulations regarding food service establishments, retail food stores, mobile food units, and roadside food vendors; and

(16) enforcing regulations controlling hazardous substances in households and workplaces.

(1) one representative from the Department of Agriculture, appointed by the commissioner of agriculture; and

(2) one representative from the Texas Education Agency, appointed by the commissioner of education.

(3) providing public education on substance abuse issues, as directed by law.

the name of the person who filed the complaint; the date the complaint is received by (2) is received by the department;

> (3)the subject matter of the complaint;

(4)the name of each person contacted in relation to the complaint;

summary of the (5) results of the review or а investigation of the complaint; and

(6) an explanation of the reason the file was closed, if the department closed the file without taking action other than to investigate the complaint.

The department shall provide to the person filing the (b) complaint and to each person who is a subject of the complaint a copy of the executive commissioner's and the department's policies and procedures relating to complaint investigation and resolution.

(c) The department, at least quarterly until final disposition of the complaint, shall notify the person filing the complaint and each person who is a subject of the complaint of the status of the investigation unless the notice would jeopardize an undercover investigation.
