He then introduced Executive Committee member Carol Harrell, who gave a presentation on the role of the Jeffersonian Institute in a proposed healthcare pilot demonstration project in Marion County.

Telecommunications is used for instantaneous medical attention, when needed.

Wallace Klussmann offered and David Alders seconded the motion to approve staff recommendation that deobligated and/or program income be used to provide an additional \$1,750,000 for the STEP Fund immediately, an additional \$300,000 for the Small Business Loan Fund to replenish it to \$1 million, an additional \$683,484 for the Micro-enterprise Loan Fund to increase it to \$1.2 million and an additional amount for the deobligated/program income portion of the Disaster Relief Fund sufficient to replenish it to \$6.5 million as of February 1, 2007, with caveats that staff provide, at the next (February 2007) Executive Committee meeting, an analysis of:

(a) each program mentioned and where we are best spending our funds; and (b) the opportunity to increase funding to the Small Towns Environment Program.
