GSD ANNUAL REPORT

The Gas Services Division Annual Report is a compilation of statistical data extracted from the individual annual financial reports filed by gas utilities. The report contains information by city about which distribution utility provides natural gas service, the number of customers served, the average annual consumption amount, and the average price per Mcf, and revenues. This information is broken down by residential, small commercial and industrial, and large commercial and industrial customers. Other information contained in the report includes average purchase prices paid by the utilities, gathering and transmission sales information, transportation revenues by company, utility plant information, gas operating revenues and expenses, miles of pipeline, and a list of names and addresses of every investor-owned and municipally-owned utility filing an annual report.

TEXAS UTILITIES CODE

This publication contains the Gas Utility Regulatory Act, some Miscellaneous Provisions, The Cox Act, Special Rules of Practice and Procedures, and Substantive Rules. All natural gas utilities are required to operate based on these rules and regulations.

This publication includes recent revisions of the statutes performed by the Texas Legislative Council as required by law. The process involved reclassifying and rearranging the statutes in a more logical order to make the statutes more accessible, understandable and usable.

GAS PIPELINE SAFETY RULES

The Pipeline Safety Rules publication is a compilation of state and federal rules and regulations governing the transportation of natural gas and hazardous liquids by pipelines within the State of Texas. Title 49 Code of Federal Regulations, Parts 191, 192, 193, 195, 199 and 40 are included in the publication as well as 16 TAC Sections 7.70-7.73 and 7.80-7.87. Other information contained in the publication includes location of Pipeline Safety offices, regional boundaries, forms, emergency telephone numbers, etc.

SIX MCF MONTHLY RESIDENTIAL GAS BILL ANALYSIS FOR TWENTY-FIVE TEXAS CITIES

A quarterly report reflecting an analysis of a six Mcf gas bill for twenty-five Texas cities providing a geographic representation of the State. Six Mcf reflects the approximate monthly average consumption of gas on an annual basis for the state, and is used in each table.
