Each service at the subcategory level will allow entry of a total cost amount that is the result of the agency's unit cost calculation outside the AIDS Regional Information and Evaluation System (ARIES) data system.

This taxonomy is subject to revision as new information and guidance is received from the Health Resources and Services Administration (HRSA).
