Strategies to Improve Oral Health

Center for Health Care Strategies highlights six states' successes

The Center for Health Care Strategies (CHCS) is a national non-profit organization devoted to improving the quality of health services for beneficiaries served by publicly financed care, especially those with chronic illnesses and disabilities. CHCS advances its mission by working directly with state and federal agencies, health plans, and providers to design and implement cost-effective strategies to improve health care quality.

The State Action for Oral Health Access initiative, launched in 2002 by the Robert Wood Johnson Foundation, was designed to address the disparities in access to dental services for low-income children and adults. The initiative, managed by CHCS, funded six states – Arizona, Oregon, Pennsylvania, Rhode Island, South Carolina, and Vermont – to develop programs to improve the oral health delivery system.

New Immunization Plans

Plan developed to increase Texas' immunization rates

Raising vaccine coverage levels for Texas children is one of the highest priorities for the Texas Department of State Health Services (DSHS). Recognizing that no single intervention

alone can be successful, DSHS has initiated a comprehensive, collaborative approach that includes proven strategies for raising vaccine coverage levels and integrates local involvement and the commitment of other public programs, private organizations, and community groups.

The Plans to Increase Immunization Rates in Texas Report, issued by the DSHS Immunization Branch on September 30, 2006, investigates several key barriers to timely vaccinations, the impact of the medical home concept, increasing public and parent education efforts, developing public-private partnerships, and other issues affecting immunization rates in Texas. HHSC Reports to the 79th Legislature

Medicaid main topic in presentations to Senate Committees

On September 19, 2006, HHSC presented to the Senate Committee on Health and Human Services regarding Medicaid Reform in Texas. HHSC focused on the significant changes that have been incorporated into the Texas Medicaid Program since 2003. Questions and Answers

Dental Issues

Question: A provider has always understood and abided by the requirement for language translators, new management refuses to provide such translation for Medicaid dental clients. The provider also refuses to allow the client-provided 19 year-old relative to be the translator. What is the citation of the Medicaid requirement that providers must ensure that translation services are provided for Medicaid clients?

Answer: The Tx. Medicaid Provider Procedures Manual, 2006 Section 1.2.5, Compliance With Federal Legislation says in essence, that all providers must comply with Title VI of Civil Rights Act, Rehabilitation Act of 1973, and Americans with Disabilities Act. The Civil Rights Act prohibits discrimination on the basis of national origin, which may require a provider to get translation services for a client who does not understand English. ADA requires translation services for blind, deaf, disabled, etc.

Medical Issues

Question: Can an audioscope be used in place of the audiometer for the hearing screening component of the THSteps well check?

Answer: Texas guidelines for hearing screening require that the child is to be screened at 1000 Hz, 2000 Hz, and 4,000 Hz at 25 dB, or at 20 dB if the provider chooses to do so. The provider is responsible in determining if the audiometric equipment being considered for purchase meets these requirements.

Question: Are the 24 hours Dietary Recall Assessment Forms available in Spanish?

Answer: These forms are currently unavailable in Spanish but THSteps CO is in the process of initiating a translation of the documents.

On October 10, 2006, HHSC presented to the Senate Finance Committee regarding uncompensated care and Medicaid hospital reimbursement related to Senate Bill 1, Article II, HHSC Riders 60 and 61. HHSC covered the following points:

- Understanding uncompensated care costs as reported by Texas hospitals (HHSC Rider 61).
- Understanding the current methodology for reimbursing hospitals (HHSC Rider 60).
- Enhancing the state's ability to be a prudent purchaser of Medicaid healthcare by determining the amount of hospital cost that should be reimbursed by Medicaid. (HHSC Rider 60).
- Identifing preliminary issues associated with the reform of the current Medicaid reimbursement system (HHSC Rider 60).
