



Registration for an exam will only be given upon receipt of the examination fee, a completed registration form, copy of a valid training certificate, and other supporting documentation as applicable. Please send exam registration materials before the exam date to the address on the registration form. Allow for mail and processing times (3-4 weeks) in your choice of two exam dates and locations. **A confirmation letter is required for admittance to an exam site and will be e-mailed/faxed/mailed to each registrant. All exam facilities have limited seating** (*Note: San Antonio location has limited parking spaces*) **and walk-ins for any exam at any location will not be allowed.** Registration by phone, fax, or email will NOT be accepted for any location. Exam locations/dates are subject to change. Should this occur all registrants would be notified as soon as possible.
