

Registration for an exam will only be given upon receipt of a completed registration form, copy of a valid training certificate, other supporting documentation as applicable, and the examination fee. Please send exam registration materials before the exam date to the address on the registration form. Allow for mail and processing times (3-4 weeks) in your choice of two exam dates and locations. Admission information/confirmation is required for admittance to an exam site and will be e-mailed/faxed/mailed to each registrant. All exam facilities have limited seating (Note: San Antonio location has limited parking spaces) and walk-ins (for any exam) at any location will not be allowed. Registration by phone, fax, or email will NOT be accepted for any location. Scheduling for exam times at the Tyler location must be made at least two business days before the examination date at the phone numbers given. Exam locations/dates are subject to change. Should this occur all registrants would be notified as soon as possible.
