- Take special note of changes in Performance Measures (see PM Guidelines in application) for this contract.
- Allocations provided with this application are tentative. Allocations may change with RW Reauthorization. Each AA needs to look at how much time they need to prepare their contracts for 4/1/07. If agencies need to present contracts in February or sooner, it may be more prudent to go with the dollar amounts in this application and be prepared for possible revisions later.
