Many citizens are entitled to a tax rebate under the recently passed Economic Stimulus Plan. However, there are more than 14,000 eligible people in the 13th District who have not submitted a 1040 or 1040A, leaving more than \$5 million in rebates unclaimed. I am working with **AARP, City of Detroit Senior Citizens Department, IRS, United Way for Southeastern Michigan,** and the **Wayne County Asset Building Coalition** to host free events at which volunteers will help you complete the necessary forms by the October 15 deadline. Bring your ID, Social Security number, the amount of your income from your Social Security, railroad retirement, or veterans benefits, and your W-2 form if you work.
