Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for Waste Management of Alameda County, Facility Number A2066, and is submitting the permit to EPA for review.

The purpose of the minor permit revision is to modify permit conditions for the landfill gas fired IC Engines (S-23 and S-24). These condition revisions will clarify the daily CO monitoring requirements for these engines and will eliminate the need to test for CO on weekends and holidays when the engine facility is not staffed and when the engine is not operating in a normal mode. This revision is minor pursuant to BAAQMD Regulation 2-6-215.

This action will not result in any emission increase. The proposed minor revision will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
