The main purpose of this proposed minor revision (Application # 15609) is to correct applicable requirements, increase the maximum firing capacity, and clarify other limits for two microturbines (S-12 and S-13). Specifically, the District is proposing to remove all federal requirements from Tables IV-C and VII-C, because the microturbines are no longer subject to 40 CFR, Part 60.752(b)(2)(iii)(B). In June 2006, EPA determined that the landfill gas treatment system, which is upstream of the microturbines, satisfies the requirements of 40 CFR Part 60.752(b)(2)(iii)(C), and that the downstream equipment is not subject to subpart B. Per the applicant's request, the District is proposing to increase the maximum permitted firing capacity for these two microturbines from 1.27 MM BTU/hour to 1.6 MM BTU/hour. The District is also proposing to remove the unnecessary landfill gas flow rate and combustion zone temperature limits and to delete the monitoring requirements related to these limits. In addition to these permit revisions for the microturbines, the District is proposing to delete the custom schedule of compliance in Section V of the permit, which applied to the landfill gas collection and treatment systems for the S-1 Shoreline Landfills, because this custom schedule of compliance expired in July 2006 and is now obsolete.

These actions will result in the following emission increases: 0.63 tons/year of PM₁₀, 0.17 tons/year of POC, 0.12 tons/year of SO₂, and 0.02 tons/year of HAPs.

This proposed minor revision will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
