Intellectual Property Agreement

In recognition of the fact that Iowa State University ("ISU"), as operator of the Ames Laboratory ("AMES" or "LABORATORY"), is engaged in the performance of contract research with the United States Government and other sponsors; in order to facilitate the technology development programs of ISU; and as a condition of my employment or appointment within the LABORATORY; I hereby agree:

- To furnish as requested, to the Ames Laboratory Office of Sponsored Research Administration or the ISU Office of Intellectual Property and Technology Transfer, information concerning items of ISU/AMES intellectual property¹ in subject-matter areas which are funded through Ames Laboratory or are primarily related to my involvement with Ames Laboratory;
- To assign all my rights and title in such ISU/AMES intellectual property to ISU or other recipients as identified in specific contracts and funding agreements;
- That any claim for compensation for any such item of intellectual property provided by the Atomic Energy Act of 1954, as amended, is hereby waived; I am as a consequence of this agreement, however, free to participate in the Ames Laboratory Inventor Incentive award program² and the ISU royalty sharing program³;
- To seek review and counsel from either the Ames Laboratory Office of Sponsored Research Administration or ISU's Office of Intellectual Property and Technology Transfer prior to the publication of items of ISU/AMES Intellectual Property and the consequent loss of patent or protection rights;
- To assist, upon request, in obtaining patents or other instruments of protection for ISU/AMES intellectual property and to execute all documents as may be required in connection therewith.
