### Understand and comply with the new Foreign Trade Regulations

October 1, 2008 the Census Bureau requires mandatory filing of export data through the Automated Export System (AES) or AESDirect. Penalties may be imposed per violation of \$1,100 to \$10,000. This may be both civil and criminal for delayed filing, false filing or use of AES to further any illegal activity.

Learn the filing requirements, data elements, parties and their responsibilities and new deadlines by mode of transportation to avoid penalties and seizure of your shipments. Learn about enforcement trends and best practices for freight forwarders and exporters alike.
