

Small Business Profile: NEVADA

Small businesses are the heart of Nevada's economy. Research by the Office of Advocacy shows that small businesses create most of the nation's net new jobs, and they bring dynamic ideas, innovative services, and new products to the marketplace. They account for almost all of the nation's employer firms and generate half of non-farm private output. New business creation is key to a state's ability to increase its gross state product, state personal income, and total state employment.¹ This small business profile uses the most recent data available to demonstrate the valuable contributions that small businesses make to Nevada's economic health.

Number of Businesses. Nevada had an estimated total of 215,800 small businesses.² Employer firms totaled 57,500 in 2006, up 5.3 percent from the previous year. Of this total, an estimated 95.8 percent, or 55,100 were small. Self-employment (incorporated and unincorporated) totaled 109,800 in 2006, a decrease from 119,900 in 2005. Non-employer firms totaled 163,500 in 2005, an increase of 7.7 percent since 2004. Women-owned Firms. In 2002, businesses owned by women numbered 47,700, represented 28.0 percent of the state's 169,500 businesses, and generated \$8.6 billion in revenues. Employer firms owned by women totaled 6,500, an increase of 24.1 percent since 1997. Women numbered 42,000 or 38.2 percent of the state's self-employed persons in 2006, a decrease of 9.4 percent from the previous year. Minority-owned Firms.³ In 2002, Asian-owned firms totaled 8,900, and 2,300 of them were employer firms; Black-owned firms numbered 4,300, and 500 were employer firms; Hispanic-owned firms totaled 9,700, and 1,300 were employer firms. American Indian and Alaska Native-owned firms numbered 1,900, and 200 of them were employer firms; while

² This estimate is based on the percent that small businesses are of the state's total businesses (see Table 1, 2004 firm size data). This percentage is multiplied by the total number of employer businesses in 2006 (Dept. of Labor). The 2005 number of non-employer firms is added to this total (Census Bureau).

³ The groups should not be added together or double counting will result, since owners may belong to more than one minority group.

Native Hawaiian and other Pacific Islander-owned businesses numbered 310, and data on employer firms are unavailable. (Source: U.S. Dept. of Commerce, Census Bureau.)

Business Turnover. An estimated 10,743 new employer firms were created in 2006, which is 4.9 percent less than the number created in 2005. Business bankruptcies totaled 178 in 2006, down from 333 the previous year, while business terminations decreased from 8,500 in 2005 to 8,400 in 2006. Employment. Small firms employed 44.3 percent of the state's non-farm private labor force in 2004, which was below the national average of 50.9 percent.⁴ These 44,500 firms accounted for 95.8 percent of the state's employer businesses, and they employed 453,100 people (Table 1). Small businesses added a total of 33,000 net new jobs between 2003 and 2004 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a share of small business income, increased by 4.7 percent, from \$6.4 billion in 2005 to \$6.7 billion in 2006.⁵ (Source: U.S. Dept. of Commerce.)

Finance. Commercial banks and savings institutions continued to be important sources of small business financing. The number of lending institution branches in the state increased in 2006 (Table 3).
