**SECURITIES AND EXCHANGE COMMISSION INSTITUTES
ADMINISTRATIVE PROCEEDINGS AGAINST SIXTEEN DELINQUENT
COMPANIES FOR FAILURE TO MAKE REQUIRED PERIODIC FILINGS**

The U.S. Securities and Exchange Commission today issued three separate public administrative proceedings against a total of sixteen companies to determine whether the registration of each class of their securities should be revoked or suspended for failure to file required periodic reports.

In the Matter of Advanced Media, Inc., et al., Administrative Proceeding File No. 3-12030

In this proceeding, the Commission instituted administrative proceedings against the following issuers:

- Advanced Media, Inc. (AVMJ)
- American Film Technologies, Inc. (AFTC)
- AmeriQuest Technologies, Inc. (AMQT)
- BPI Packaging Technologies, Inc. (BPIE)
- CML Group, Inc. (CMLK)
- Compositech, Ltd. (CTEK)
- Dispatch Management Services Corp. (DMSC)
- Eglobe, Inc. (EGLOQ)

In this Order, the Division of Enforcement alleges that the eight issuers are delinquent in their required periodic filings with the Commission. The Division of Enforcement also alleges that the common stock of each of these issuers is quoted on the Pink Sheets.

In the Matter of Transmedia Asia Pacific, Inc. 3-12032

In this proceeding, the Commission instituted administrative proceedings against the following issuer:

- Transmedia Asia Pacific, Inc. (MBTA)

In this Order, the Division of Enforcement alleges that MBTA is delinquent in its required periodic filings with the Commission. The Division of Enforcement also alleges that the common stock of MBTA is quoted on the Pink Sheets.

In each of these proceedings, instituted pursuant to Securities Exchange Act of 1934 (Exchange Act) Section 12(j), a hearing will be scheduled before an Administrative Law Judge. At each hearing, the judge will hear evidence from the Division of Enforcement and the respondents to determine whether the allegations of the Division of Enforcement contained in the Order, which the Division alleges constitute violations of Exchange Act Section 13(a) and Rules 13a-1 and 13a-13 thereunder, are true. The judge in each proceeding will then determine whether the registrations pursuant to Exchange Act Section 12 of the securities of these respondents should be revoked, or in the alternative, suspended for a period not exceeding twelve months. The Commission ordered that the Administrative Law Judge in each proceeding issue an initial decision not later than 120 days from the date of service of the order instituting proceedings.
