RUNNING MATES

In accordance with 14 USC 726(a), the Secretary shall assign a running mate to each Reserve officer in an active status not on the active duty promotion list (ADPL). The officer initially assigned as a running mate under this section shall be that officer on the ADPL of the same grade who is next senior in precedence to the Reserve officer concerned.

Officers on the ADPL who have been promoted from below the promotion zone, or placed out of line for promotion will not be assigned as running mates. Consequently, more than one officer on the ADPL could become a running mate in the course of a year due to ADPL changes. For this reason, running mate signal numbers do not appear in this publication.

TOTAL COMMISSIONED SERVICE

Total commissioned service (TCS) of an officer who has served continuously in the Reserve following appointment in the grade of ensign shall be computed from the date on which that appointment was accepted.

A reserve officer initially appointed in a grade above ensign is considered to have the total commissioned service:

- a. previously performed in a grade above commissioned warrant officer at the time of appointment; or,
- b. the same total commissioned service as an officer of the Regular Coast Guard who has served continuously from an original appointment as ensign, and who has not lost numbers or precedence, and who is, or was at the time of original appointment, immediately junior to the reserve officer, whichever period of commissioned service is greater.

The TCS Years column is used as a guide for determining when captains shall be removed from an active status. In accordance with 14 USC 740, the Secretary shall remove from an active status a Reserve officer serving in the grade of captain who has completed thirty years of total commissioned service. If removed from active status, the date shall be on 30 June next following the date on which the officer completes thirty years of total commissioned service as computed under this section.

RESERVE SIGNAL NUMBER

Each year at the time a new Register is printed, reserve officers are assigned a new reserve signal number. This number designates their seniority in relation to other reserve officers and bears no relation to signal numbers on the ADPL.
