Thank you for submitting information on the above referenced project for our review pursuant to Section 106 of the National Historic Preservation Act (P.L. 89-665, as amended) and the Advisory Council on Historic Preservation's regulation 36 CFR Part 800, which requires identification and evaluation of cultural resources.

We have reviewed the August 2006 report entitled *Cultural Resource Investigations, Phase I Survey & Phase II Testing, Norborne Electric Plant Project, Carroll County, Missouri* by the Environmental Research Center of Missouri, Inc. Based on this review it is evident that a thorough and adequate cultural resources survey has been conducted of the project area. We concur with the investigator's recommendation that Farmsteads Nos. 1, 2, 3, 4 and 5 and archaeological sites 23CA1161, 23CA1162, 23CA1163, 23CA1164, 12CA1165, 23CA1166, 23CA1167, 23CA1168 and 23CA1169 are not eligible for inclusion in the National Register of Historic Places. We have no objection to the initiation of project activities.
