## SELF-REGULATORY ORGANIZATIONS

### PROPOSED RULE CHANGE

The Pacific Stock Exchange filed a proposed rule change (SR-PSE-91-38) pursuant to Rule 19b-4 to amend the criteria of market makers to be eligible in the automatic execution feature of the Pacific Option Exchange Trading System. Publication of the proposal is expected in the Federal Register during the week of January 13. (Rel. 34-30160)

### TEMPORARY APPROVAL ON AN ACCELERATED BASIS OF PROPOSED RULE CHANGE

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-91-05) that would extend the temporary approval period for GSCC's service to convert yield-based trades to priced trades. The Commission has approved the proposal on an accelerated basis until January 31, 1993. Publication of the proposal is expected in the Federal Register during the week of January 13. (Rel. 34-30170)

### APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-NYSE-91-41) filed pursuant to Rule 19b-4 by the New York Stock Exchange to increase the NYSE's continuing annual listing fees. (Rel. 34-30171)

**ACQUISITION OF SECURITIES**

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
