CIVIL PROCEEDINGS

RECEIVER APPOINTED FOR CUSTOM TRADING COMPANIES; JOHN HALL, JR. AND OTHERS ENJOINED

The Commission announced that on April 27, 1992 in a pending civil action alleging a \$10 million fraud involving investment contract securities, the Honorable Edward C. Prado, U.S. District Judge for the Western District of Texas, San Antonio Division, entered an Agreed Order Appointing a Receiver for Custom Trading International Corporation, Executive Capital Securities, Inc., Custom Trading de Mexico, S.A. de C.V. and Custom Trading USA Corporation. Judge Prado also entered an Agreed Order of Preliminary Injunction and Other Equitable Relief against John A. Hall, Jr. (Hall), Roger A. Bishop (Bishop), Theodore (Ted) Carney (Carney), Don Estes (Estes) and the foregoing corporate defendants. The Court appointed Ronald E. Mendoza, Esq. of San Antonio, Texas, as receiver and directed Mr. Mendoza to, among other things, take complete and exclusive custody and control of all the assets and property of the corporate defendants.

The Court preliminarily enjoined the defendants from further violations of the registration and securities fraud provisions of the federal securities laws. With certain limited exceptions, Defendants Hall, Bishop, Carney and Estes continue to be subject to a freeze of their assets. The defendants agreed to the entry of the Receivership Order and Injunction without admitting or denying the allegations in the Commission's complaint. [SEC v. ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Following is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
