CIVIL PROCEEDINGS

CIVIL INJUNCTIVE ACTION FILED AGAINST SOUTHEAST FIRST CAPITAL CORPORATION, CLIFFORD BUCK AND THOMAS BUCK

The Commission filed an action in the U.S. District Court for the Southern District of Florida on July 31, 1992 against Southeast First Capital Corporation, Clifford W. Buck and Thomas W. Buck alleging violations and aiding and abetting of violations of Section 17(a) of the Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5 thereunder.

The Commission's complaint alleges that the defendants intentionally failed to disclose certain material facts regarding Southeast's equipment leasing activities in Southeast's annual report on Form 10-K for the fiscal year ended February 28, 1989 and in a Southeast private placement memorandum.

The complaint further alleges that the defendants used a significant portion of the proceeds of a private placement of Southeast securities to repay a loan from Clifford W. Buck to Southeast, without disclosing this intended use of proceeds in the private placement memorandum.

Simultaneously with the filing of the Commission's complaint, defendants Southeast First Capital Corporation and Clifford W. Buck consented, without admitting or denying the allegations in the Commission's complaint, to the entry of permanent injunctions restraining them from future violations of Section 17(a) of the Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. Clifford W. Buck also consented to the entry of an order prohibiting him from serving as an officer or director of any issuer that has a class of securities registered under Section 12 of the Exchange Act or that is required to file reports under Section 15(d) of the Exchange Act. INVESTMENT COMPANY ACT RELEASES

COLUMBIA INTERNATIONAL STOCK FUND, INC.

A notice has been issued giving interested persons until August 25 to request a hearing on an application filed by The Columbia International Stock Fund, Inc. for a conditional order under Section 6(c) of the Investment Company Act exempting applicant from the provisions of Section 12(d)(3) of the Act and Rule 12d3-1 thereunder. The exemptions apply to the extent necessary to permit applicant to invest in equity and convertible securities issued by foreign companies that, in each of their most recent fiscal years, derived more than 15% of their gross revenues from their activities as a broker, dealer, underwriter or investment adviser, provided such investments meet the conditions in the proposed amendments to Rule 12d3-1. (Rel. IC-18876; International Series Rel. 430 - July 31)

OHIO NATIONAL EQUITY FUND, INC., ET AL.

A conditional order has been issued on an application filed by Ohio National Equity Fund, Inc. and The O.N. Equity Sales Company under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Act and Rule 22c-1 thereunder. The conditional order permits applicants to impose a contingent deferred sales charge (CDSC) on redemptions of shares of the Fund sold with no initial sales charge because of a volume discount, and to waive the CDSC under certain circumstances. HOLDING COMPANY ACT RELEASES

DOMINION RESOURCES, INC., ET AL.

An order has been issued in connection with the proposed indirect acquisition of an interest in an Argentine electric public-utility company, Central Termica Alto Valle S.A. (Alto Valle), by Dominion Resources, Inc. (Dominion), a Virginia public-utility holding company exempt from registration under Section 3(a)(1) of the Act pursuant to Rule 2. The order grants exemptions under Section 3(b) from all provisions of the Act to Alto Valle and Dominion Management Argentina S.A., a wholly owned indirect Argentina subsidiary of Dominion that will operate Alto Valle. (Rel. 35-25598; International Series Rel. 431)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The Commission has published a notice of filing for comments from interested persons of a Philadelphia Stock Exchange proposed rule change (SR-PHLX-92-4) to amend certain PHLX rules to facilitate the trading of NASDAQ/National Market System (NMS) securities on the PHLX pursuant to those securities being listed on the Exchange or the granting of unlisted trading privileges (UTP). This filing is made in connection with the Joint Reporting Plan governing the collection, consolidation and dissemination of quotation and transaction information for NASDAQ/NMS securities listed on an exchange or traded on an exchange pursuant to a grant of UTP. Publication of the Release in the Federal Register is expected during the week of August 3. (Rel. 34-30984)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
