ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES
EXCHANGE COMMISSION

DOUGLAS WRIGHT ORDERED TO CEASE AND DESIST

The Commission issued an Order Instituting Proceedings pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) and Findings and Order against Douglas Wright (Wright). The Order requires Wright to cease and desist from committing or causing any violation or any future violation of Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. Simultaneously, the Commission accepted Wright's Offer of Settlement in which, without admitting or denying the matters set forth in the Order, he consented to the issuance of the Order. The Order finds that during the period from March 1989 to July 1989 Wright issued and participated in the issuance of false and misleading public statements concerning Dimensional Visions Group, Ltd. (DVGL). Wright was a vice president of DVGL during this time period. (Rel. 34-32758)

JOHN VIDAKOVICH PERMANENTLY DENIED PRIVILEGE OF APPEARING OR PRACTICING BEFORE THE COMMISSION

The Commission instituted public administrative proceedings against John L. Vidakovich (Vidakovich), previously an attorney licensed to practice law in Wyoming and Colorado. Simultaneously, Vidakovich submitted an Offer of Settlement, which the Commission accepted. Accordingly, the Commission entered an Order Instituting Proceedings and Opinion and Order Pursuant to Rule 2(e) of the Commission's Rules of Practice which found, among other things, that the Commission filed an injunctive suit against Vidakovich on September 25, 1991 in the District of Utah in which the Commission alleged that from at least 1986 until November 1987, Vidakovich utilized his position as an undisclosed control person of Calico Corporation (Calico) to make use of Calico's funds for non-corporate purposes, issue false or misleading press releases and file a false and misleading document with the Commission. Furthermore, the Commission alleged that Vidakovich sold Calico stock after manipulating the price of the stock.

The Order also contains findings that Vidakovich consented, without admitting or denying any of the allegations in the Commission's complaint, to the entry of a Final Judgment of Permanent Injunction by the District of Utah which permanently enjoined Vidakovich from further violations of the antifraud, registration and reporting requirements of the federal securities laws.

The Commission's Order permanently denies Vidakovich the privilege of appearing or practicing before the Commission as an attorney. (Rel. 34-32761)

INVESTMENT COMPANY ACT RELEASES

GREAT HALL VALUE TEN TRUST, SERIES 1, ET AL.

A conditional order has been issued on an application filed by Great Hall Value Ten Trust, Series 1, et al. under Section 6(c) of the Investment Company Act exempting applicants from Sections 14(a) and 19(b) of the Act and Rule 19b-1 thereunder. (Rel. IC-19646 - August 23)

DAILY MONEY FUND, ET AL.

A conditional order has been issued pursuant to Rule 17d-1 under the Investment Company Act to Daily Money Fund, et al. The order amends an existing order that permits the Fidelity family of funds to operate a joint trading account that invests solely in repurchase agreements, with maturities not exceeding seven days, collateralized by U.S. government securities. The amended order permits the establishment of one or more new joint accounts, in addition to the existing joint account and certain entities associated with Fidelity but not subject to the Act to participate in the joint accounts. The amended order also permits the joint accounts to invest in repurchase agreements with maturities of up to sixty days, rather than the current limit of seven days and permits the joint accounts to invest in various short-term money market instruments and tax-exempt obligations, in addition to repurchase agreements. Further, the amended order permits the use of first tier securities, in addition to U.S. government securities, as collateral for the repurchase agreements. (Rel. IC-19647 - August 23)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of three exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. The exchanges and number of issues are as follows: Boston Stock Exchange - 6 issues (Rel. 34-32776); Chicago Stock Exchange - 24 issues (Rel. 34-32777); and Philadelphia Stock Exchange - 24 issues (Rel. 34-32779).

DELISTING GRANTED

An order has been issued granting the application of Alpine Meadows of Tahoe, Inc. to strike from listing and registration its Common Stock, \$.25 Par Value, on the Pacific Stock Exchange. (Rel. 34-32778)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The Participants Trust Company filed a proposed rule change (SR-PTC-93-02) relating to a modification of PTC's method of paying principal and interest to participants. Publication of the proposal is expected in the Federal Register during the week of August 23. (Rel. 34-32772)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-93-32) relating to the listing and trading of a hybrid debt security exchangeable for common stock. Publication of the proposal is expected in the Federal Register during the week of August 23. (Rel. 34-32786)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-MSRB-93-4) filed by the Municipal Securities Rulemaking Board to amend the Board's Arbitration Code to reflect recent amendments to the Uniform Code of Arbitration. Publication of the proposal is expected in the Federal Register during the week of August 23. (Rel. 34-32780)
