### ADOPTION OF AMENDMENTS TO SHAREHOLDER COMMUNICATION RULES

The Commission adopted: (a) amendments to Rule 14b-1 under the Securities Exchange Act of 1934 relating to brokers' obligations in connection with forwarding communications to beneficial owners; (b) new Rule 14a-13, a registrant-related corollary to Rule 14b-1; and (c) corresponding amendments to Rule 14c-7. The amendments are intended to allow for the most advantageous implementation of the system of direct communication provided under those rules. (Rel. 34-22533)

## ADMINISTRATIVE PROCEEDINGS

---

### PROCEEDINGS AGAINST ALAN BENNETT HARP DISMISSED

The Commission dismissed proceedings against Alan Bennett Harp, a Houston securities salesman. An administrative law judge had found that, during July 1982, Harp manipulated the price of the common stock of Wainoco Oil Corporation on the New York Stock Exchange. The Commission, although noting that there were a number of suspicious circumstances in connection with Harp's activities involving Wainoco, concluded that the evidence did not establish that Harp had engaged in a manipulation. ## INVESTMENT COMPANY ACT RELEASES

---

### THE NORTHWESTERN MUTUAL LIFE INSURANCE COMPANY

An order has been issued granting The Northwestern Mutual Life Insurance Company, et al. exemptions from Sections 2(a)(32), 2(a)(35), 22(c), 22(d) and 27(c)(1) of the Investment Company Act and Rules 6e-2(b)(1), (b)(12), (b)(13)(iv), (c)(1)(ii), (c)(4) and 22c-1. The exemptions will permit the use of a contingent deferred sales load in the issuance and funding of certain single premium variable life insurance contracts. (Rel. IC-14758 - Oct. 16)

### EASTERN UTILITIES ASSOCIATES

A notice has been issued giving interested persons until November 8 to request a hearing on a proposal by Eastern Utilities Associates, a registered holding company, to acquire, through a new, wholly-owned New Hampshire subsidiary, joint ownership interests aggregating 11.26721% in the Seabrook nuclear generating project in New Hampshire from four non-associated companies and to engage in certain financing and related transactions. ### IMMEDIATE EFFECTIVENESS OF AMENDMENT TO CQ PLAN

The participants in the Consolidated Quotation Plan (CQ Plan) have filed an amendment to the CQ Plan to change the normal operating hours of the Consolidated Quotation System (CQS) to comport with the decision of each CQ Plan participant to open its market for trading at 9:30 a.m. eastern time beginning September 30, 1985. The amendment has become effective under paragraph (C)(3)(iii) of Rule 11Aa3-2 under the Securities Exchange Act of 1934. (Rel. 34-22527)

### APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Municipal Securities Rulemaking Board (SR-MSRB-85-17) to amend its Rules G-12 on uniform practice and G-15 on confirmation, clearance and settlement of customer transactions to provide a standard procedure for the handling of interest payment claims based on deliveries of registered and bearer securities prior to the record date of the securities. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
