COMMENT PERIOD FOR REPROPOSED RULE 13H-1 EXTENDED

The Commission is extending the public comment period for repropoed Rule 13h-1, which establishes a large trader reporting system. The comment period for Securities Exchange Act Release No. 34-33608, which was scheduled to close on April 18, 1994, has been extended to June 3, 1994. FOR FURTHER INFORMATION CONTACT: Nicholas T. ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDING AS TO WILLIAM HEBDING, C.P.A.

The Commission has issued an Order Instituting Public Proceeding and Opinion and Order pursuant to Rule 2(e) of the Commission's Rules of Practice against William J. Hedding, a certified public accountant and the former chairman and chief executive officer of Comptronix Corporation. Simultaneously, the Commission accepted Hedding's Offer of Settlement, whereby Hedding consented, without admitting or denying the findings contained therein, to entry of an Order permanently denying him the privilege of appearing or practicing before the Commission as an accountant.

The Commission found that Hedding was permanently enjoined from further violations of certain provisions of the federal securities laws in an action filed by the Commission and that he engaged in improper professional conduct within the meaning of Rule 2(e) of the Commission's Rules of Practice. The Commission's complaint alleged, among other things, that Hedding and two other senior officers engaged in a scheme which caused Comptronix to report substantially inflated sales and net income in its financial statements filed with the Commission between 1989 and 1992. The Final Judgment as to Hedding was entered by consent on April 7, 1994 in SEC v. Hedding, et al., D.D.C., Civ. 94-0677, TPJ, (LR-14034; AAE Rel. No. 544). (Rel. 34-33897; AAE Rel. 548)

JAMES CATHEY, JR. BARRED

The Commission announced that administrative proceedings were instituted against James W. Cathey, Jr. (Cathey) of Las Cruces, New Mexico. Simultaneously, Cathey submitted an Offer of Settlement consenting to the entry of an Order, which contains findings that he was previously permanently enjoined by the U.S. District Court for the Western District of Texas, El Paso Division, from violations of the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934 (LR-13981).

Cathey is barred from association with any broker, dealer, investment company, investment adviser or municipal securities dealer, with a right to reapply in eighteen months to the appropriate self-regulatory agency or, where there is none, to the Commission. (Rel. 34-33898; IA-1410)

CEASE AND DESIST ORDER ENTERED AGAINST LUIS DUBON, JR.

Today, the Commission announced the issuance of an Order pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) against Luis E. Dubon, Jr. (Dubon) requiring Dubon to permanently cease and desist from committing or causing any violation of, or any future violation of, Section 16(a) of the Exchange Act and Rules 16a-2 and 16a-3 promulgated thereunder. Dubon, without admitting or denying the allegations in the Commission's Order, consented to its entry. The Order finds that Dubon, who is a director of BanPonce Corporation (BanPonce), a San Juan, Puerto Rico bank holding company, failed to timely report changes in his ownership of BanPonce securities on Forms 4 and 5 (thirteen Forms 4 and one Form 5 from one week to eighteen months late). Dubon's late filed Form 4 Reports involved transactions with a value of approximately \$4.4 million. (Rel. 34-33917)

INVESTMENT COMPANY ACT RELEASES

ATLAS ADVISERS, INC., ET AL.

A conditional order has been issued on an application filed by Atlas Advisers, Inc., et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits the applicants to issue multiple classes of shares representing interests in the same portfolio of securities, assess a contingent deferred sales charge (CDSC) on certain redemptions of shares, and waive the CDSC in certain instances. SELF-REGULATORY ORGANIZATIONS

AMENDMENT TO APPLICATION FOR EXEMPTION FROM REGISTRATION

The Clearing Corporation for Options and Securities filed an amendment to its application for an exemption from registration as a clearing agency under Section 17A of the Securities Exchange Act of 1934. Publication of the notice in the Federal Register is expected during the week of April 18. (Rel. 34-33911)

UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of three exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. The exchanges and number of issues are: Chicago Stock Exchange - 13 issues (Rel. 34-33907); Boston Stock Exchange - 1 issue (Rel. 34-33908); and Cincinnati Stock Exchange - 10 issues (Rel. 34-33910).
