ENFORCEMENT PROCEEDINGS

JUDGMENTS ENTERED AND ADMINISTRATIVE SANCTIONS IMPOSED AGAINST ANN HILES, THOMAS GREULICH, SR. AND ROBERT MCMAHON

The Commission announced the entry of final judgments of permanent injunction and other relief against Ann E. Hiles, Thomas L. Greulich, Sr. and Robert T. McMahon. The judgments enjoin them from further violations of Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 thereunder, order disgorgement, and note the appropriateness of civil penalties under the Insider Trading Sanctions Act of 1984.

The Commission alleged that Hiles, Greulich, and McMahon engaged in illegal insider trading in Anchor Glass Container Corporation stock prior to the announcement of a tender offer for the stock. Hiles, Greulich and McMahon consented, without admitting or denying the allegations, to the entry of the judgments. The Commission waived payment of penalties and disgorgement based upon the defendants' demonstrated inability to pay.

Hiles, Greulich and McMahon also consented to the entry of orders instituting administrative proceedings against them pursuant to Section 15(b) of the Exchange Act, making findings and imposing remedial sanctions. The orders permanently bar Hiles and Greulich from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. PERMANENT INJUNCTIONS, PENALTIES AND CONTEMPT ORDER ENTERED AGAINST ERIK SCHRADER AND CREATIVE INCOME SYSTEMS, A/K/A C.I. SYSTEMS

The Commission announced that on November 22 the United States District Court for the District of Columbia entered an Order of Contempt and Final Default Judgment of Permanent Injunction and Other Relief against Erik E. Schrader of Fairfax County, Virginia, and his company, Creative Income Systems a/k/a C.I. Systems (CIS). In its action, the Commission alleged that defendants were engaged in a fraudulent scheme to offer and sell so-called "prime bank securities" to investors in the D.C. metropolitan area through the use of classified advertisements, recorded telephone messages, and training seminars or workshops, during which investors were assured unrealistic returns on investment without any disclosed risk or effort on their part.

Defendant Schrader was also found in contempt of Court for having violated two prior court orders requiring him, among other things, to cease the offer and sale of unregistered securities and to account for investor funds. The Court ordered the incarceration aspect of its Order held in abeyance pending further order of the Court. The Court ordered defendants to disgorge the sum of \$170,352, and pay a penalty of \$170,352. The Court also permanently enjoined defendants from violations of the registration and antifraud provisions of the federal securities laws. [SEC v. Creative Income Systems, a/k/a C.I. HOLDING COMPANY ACT RELEASES

SYSTEM ENERGY RESOURCES, INC., ET AL.

A notice has been issued giving interested persons until December 22 to request a hearing on a proposal by Entergy Corporation, a registered holding company, and its wholly owned subsidiary companies System Energy Resources, Inc. (SERI), Arkansas Power & Light Company, Louisiana Power & Light Company, Mississippi Power & Light Company, and New Orleans Public Service Inc. SERI proposes from time to time through December 31, 1996 to issue and sell one or more series of its First Mortgage Bonds in an aggregate principal amount not to exceed \$265 million and to enter into arrangements for the issuance and sale of tax-exempt revenue bonds in an aggregate principal amount not to exceed \$235 million. DELISTING GRANTED

An order has been issued granting the application of the American Stock Exchange to strike from listing and registration Megafoods Stores, Inc., 10.25% Senior Notes, due 2000. (Rel. 34-35006)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission approved on an accelerated basis a proposed rule change (SR-PTC-94-05) filed by the Participants Trust Company providing for the early principal and interest distribution on Government National Mortgage Association II securities. The Commission granted accelerated approval to a proposed rule change and Amendment No. 1 to the proposed rule change (SR-CBOE-94-36) filed by the Chicago Board Options Exchange granting permanent approval of the Exchange's Modified Trading System Pilot Program. PROPOSED RULE CHANGE
