### NASD ACTION AGAINST WILLIAM JOHNSON SET ASIDE

JUN 26 1974

An order has been issued setting aside sanctions imposed by the NASD on William M. Johnson, of La Jolla, California. Johnson was vice-president of Buttonwood Securities, Inc., formerly an NASD member.

The sanctions were based on the NASD's finding that Johnson was responsible for a net capital violation by Buttonwood in August of 1971. Although the NASD acknowledged on review that its finding of violation was based on a "computational error," it sought to sustain the finding on a different basis. The Commission, however, stated that it could not affirm the NASD "on the basis of a fact that was not found." It also noted that the record before it did not appear to support a finding of violation on the new basis urged by the NASD. (Rel. 34-10859)

## COMMISSION ANNOUNCEMENTS

### REGULATION A EXEMPTIONS OF THE BOLTON GROUP, LTD. AND EKG SERVICE CORP. SUSPENDED

The SEC order of December 11, 1973, temporarily suspending the Regulation A exemptions from registration under the Securities Act of 1933 with respect to public offerings of stock of The Bolton Group, Ltd., a New York corporation, and EKG Service Corp., a Delaware corporation, have become permanent. Bolton's and EKG's securities were to be sold by Park Securities, Inc. of New York City.

Under notifications filed on June 14, 1972, and June 28, 1972, respectively, Bolton offered 100,000 units at \$1.25 per unit and EKG Service Corp. offered 100,000 shares of common stock at \$5 per share. According to the orders, the Commission has reason to believe that: (a) the notification and offering circular of both Bolton and EKG contained untrue statements of material facts and omitted to state material facts, particularly with respect to the distribution of the offering, the identity of underwriters and purchasers and the interests of such persons in the distribution, the amount of securities to be sold, and the price to be paid by the public, the compensation of underwriters, the manner in which the securities would be traded in the after-market; and (b) the offering was made in violation of the antifraud provisions of the securities laws.
